Grow BC

- We're developing Grow BC to help young farmers access land, and support fruit and nut growers, as well as processors, to expand local food production.
- It isn't unique to B.C., but one of our greatest challenges for new and young farmers is accessing land.
- Some of highest quality agricultural soil is found in and around the lower mainland, where escalating real estate prices have also driven up the cost of farm land.
- In B.C. the issue of people building monster homes on Agricultural Land has played a part in that.
- With this farmland becoming out of reach for a new entrant farmer, we're left looking at other solutions to ensure that good farmland is being farmed.
- One option is to have young and new farmers lease farmland.
- We've supported a pilot project in Metro Vancouver being led by the Young Agrarians/Farm Folk City Folk that aims to match new entrant farmers with land owners looking for someone else to farm their land.
- It's a very interesting model, and one we want to explore in greater detail in the coming months and years.

B.C. hazelnut growers receive support to revitalize local orchards

VICTORIA - The British Columbia hazelnut industry will have a chance to regenerate after facing challenges with eastern filbert blight (EFB).

EFB is a serious disease, commonly found in hazelnut orchards, that has affected crops throughout the province.

"Hazelnut growers in B.C. have faced major setbacks over the past decade, but this funding will help regrow and revitalize a sector that has enormous possibilities," said Lana Popham, Minister of Agriculture. "This funding will help bring processing opportunities that add value to farmers, and offers consumers more B.C. products. My mandate includes Grow BC, and that includes hazelnuts."

The Ministry of Agriculture is providing the BC Hazelnut Growers Association (BCHGA) with \$300,000 in funding over the next three years. The funding will allow growers to replace hundreds of acres of dead and diseased orchards with EFB-resistant varieties, and will further expand hazelnut acreage in B.C. with new planting.

"This announcement is a very welcome and exciting step in the re-establishment and expansion of a promising industry in British Columbia," said Walter Esau, who is on the board of directors for the BCHGA. "The BC Hazelnut Growers Association has worked hard over the past decade to keep a once thriving industry alive, and with the help of the B.C. government, this is being made possible. We are excited about the future of hazelnuts in B.C., and welcome any enquiries about our industry."

The Ministry of Agriculture's Grow BC was established to support the fruit and nut growers, and processors, to expand local food production and to help young farmers access land. Grow BC offers targeted programs, such as the Hazelnut Renewal Program, to make sure the people who are passionate about working in agriculture have opportunities to work within the sector.

Okanagan Falls recognized as a distinct wine-producing area

OKANAGAN FALLS - Wine drinkers will be able to easily identify bottles of wine from Okanagan Falls now that the area is officially recognized for its wine production.

Changes to the Wines of Marked Quality Regulation mean eligible wineries on the east

side of the Okanagan Valley from Vaseux Lake to just north of Shuttleworth Creek can label their wines as coming from Okanagan Falls. Including the area-specific labelling helps people recognize the wines are made with local grapes, and enhances the area's overall reputation as a wine and agri-tourism destination.

"British Columbia wine is enjoyed both here at home and around the world, and consumers will now be able to identify the unique terroir and wine from Okanagan Falls," said Lana Popham, Minister of Agriculture. "Congratulations to the wine producers in this fantastic area and I look forward to seeing the Okanagan Falls label on BC VQA bottles soon."

Okanagan Falls is the second sub-appellation in British Columbia. The other is the Golden Mile Bench near Oliver.

"There is a tremendous amount of collaboration, science and research that goes into defining more precise regions within an appellation, which is based very much on terroir," said Miles Prodan, CEO and president, BC Wine Institute. "Wine is about place, and we are proud of the hard work by industry and wineries coming together to define and certify these meaningful and scientifically unique regions producing distinctive world-class wines. This is a true testament to the maturation and progress of BC VQA's premium wine industry."

Other changes to the regulation prohibit the use of unregulated geographical indications (areas) on BC Wine Authority members' wine labels, and formalize an April 2018 announcement that the Thompson Valley, Shuswap, Lillooet and the Kootenays are also recognized as new geographical indications, a standard element of appellation systems used around the world.

"We are thrilled with the announcement today of B.C.'s second official sub-appellation, Okanagan Falls. Our focus is to produce single vineyard wines to showcase the terroir of each individual vineyard," said Jim D'Andrea, proprietor, Noble Ridge Vineyard & Winery. "Having a legal definition to include 'Okanagan Falls' on the label is one step further in helping consumers relate to the unique terroir where the grapes are grown and taste the distinct difference from this specific area."

An additional change implements a flat fee for small wineries to enable and encourage more wineries to participate in the BC Wine Authority's programs.

Quick Facts:

- * Okanagan Falls, located in the southern Okanagan, includes about 150 hectares of vineyards that produce over 1,100 tonnes of grapes per year.
- * Wineries in Okanagan Falls include the BC Wine Studio, Blue Mountain Vineyard and Cellars, Bonamici Cellars, Liquidity Wines, Meyer Family Vineyards, Noble Ridge Vineyards, Stag's Hollow Winery & Vineyard, Wild Goose Vineyards and Synchromesh Wines.
- * British Columbia now has 12 official geographical indications.

- * The other six geographical indications are British Columbia (provincial), Vancouver Island, Gulf Islands, Fraser Valley, Similkameen Valley and the Okanagan Valley.
- * Currently there are four eligible wineries in the Kootenay region, one in Lillooet, eight in Shuswap, and four in the Thompson Valley.

2018 Wildfire Impact on AGRI

- The 2018 wildfire season has thankfully been less severe than 2017, but AGRI staff remain focused on supporting our farmers, ranchers and growers during the summer months.
- Ministry staff haven't had many recent requests for support from our agriculture sector in recent days with the fires, but continue to keep in touch with industry associations and farmers' institutes in case support is needed.
- Our Business Risk Management team is still working with producers who were impacted by the 2017 wildfires through our Agri-Recovery support, to ensure they're up and running again.

Cannabis on ALR

- Our government recently announced a new policy that gives local and First
 Nation governments the ability to prohibit future construction of concrete, bunker-style cannabis production facilities on the ALR in their communities.
- The regulatory change allows individual local and First Nation governments to make decisions regarding cannabis production on the ALR that align with local planning and priorities in their communities.
- We recognize that in some communities concrete bunker-style cannabis
 production facilities are not suitable for the ALR and have provided local governments
 with the clear ability to make this decision to prohibit them in their jurisdictions, and
 preserve farmland.
- The policy recognizes the federal government's plans to license cannabis production in open fields, greenhouses and bunker style facilities, and this provides clear options for communities in regulating them.
- This also prohibits local governments from banning commercial cannabis production in existing licensed operations or in open fields in the ALR moving forward.
- The changes only pertain to land in the ALR. Local governments have the ability to regulate or prohibit cannabis production on other land in their communities.

I thought you had recused yourself from Cannabis because of a conflict?

- In September of 2017, I met with the Conflict of Interest Commissioner to discuss what I believed could be a perceived conflict of interest on the cannabis file.
- In December of 2017, I asked Minister Doug Donaldson to act as the alternate Agriculture Minister with respect to any Ministerial decisions that may be required related to cannabis.
- I have recused myself from all Cabinet discussions on the legalization of cannabis, and have had no part to play in the decision making.
- Now that the decision relating to cannabis production on the ALR is made, the
 Conflict of Interest Commissioner has let me know that he considers me free to

comment on the government policy.

Why not ban bunkers on the ALR all together if you care about farmland? Why make local governments deal with the decision?

- The preservation of agricultural land in the ALR is a priority for the Province.
- We recognize that in some communities concrete bunker-style cannabis production facilities are not suitable for the ALR and have provided local governments with the clear ability to make this decision to prohibit them in their jurisdictions.
- The new policy allows individual local and First Nation governments to make decisions regarding cannabis production that align with local planning and priorities in their communities including the preservation of farmland.

- B.C.'s tree fruit industry is composed of approximately 800 growers managing 6,474 hectares (16,000 acres) of tree fruit in crops in the Okanagan, Similkameen and Creston Valleys. Those growers produced nearly 129,000 tonnes of fruit in 2016 worth more than \$116 million.
- In 2018, the Province provided an additional \$300,000 in funding for the replant program, to meet the demand from tree fruit growers; as of July 2018, the tree fruit sector has access to \$5.5 million of funding to support replanting until 2021.
- In February 2018, a new \$5-million Tree Fruit Competitiveness Fund was announced.
- The fund is open to tree fruit growers, producers and processors to support three key areas of priority:
 - Research: cultivar, disease and pest research
 - Marketing: export market opportunities and market development research
 - Infrastructure: sector-based infrastructure modernization such as new equipment.
