Input Requested: Planning for Forest Investment Opportunities in Northwest BC -- Online Meeting
Planning for Forest Investment Opportunities in Northwest BC

Coast Mountains Resource District (CMD), with LBJ funding, commissioned a report to better understand the second growth forest estate in northwest British

Columbia, specifically in the Management Units identified as the Cascadia, Kalum, North Coast and Pacific Timber Supply Areas (TSAs) and Tree Farm Licences – TFL 1 and TFL 41.

In pursuing this project, CMD staff were mindful of the impending timber supply fall-down in interior management units, and local inability to proactively address critical questions that are likely to be asked related to practical wood supply issues.

Attached is the result of this contract, issued to Silverwood Consulting, and completed in March, 2016. **We would like you to be aware of this project, and have the chance to discuss and reflect/respond to its recommendations – some of which relate to provincial priorities/programs/data management, as well as more regional and local issues.**

Opportunities R...

For context: in these north-west management units, most wood processing facilities have closed over the past 15 years and there is a very heavy reliance on export/market-based harvesting of a routinely undercut allowable annual cut (AAC). Many dozens of investors have walked through the CMD doors with second growth management questions, which Ministry staff have not had the resources to answer – in appropriate detail - with confidence (with the downturn in harvesting, FLNR staffing levels have significantly dropped, and at the same time, licencees have not had the capacity or mandate to address strategic data management issues).

Currently operating forest companies, local communities as well as FLNR have a shared interest in being able to access accurate information on 2nd growth stands. This includes describing and quantifying the younger aged segment of the timber harvest land base (less than 100 years old), in ways that can be used to inform strategic and operational business decisions.

The body of the report delves into available data, strategic and operational investment plans, identifies information gaps and needs, and identifies potential opportunities related to second growth economy in CMD. It is not exhaustive or to be considered on the level of a Silviculture Strategy, although significant effort is invested toward describing the current forest estate to stimulate conversation on future silviculture investment planning.

The conclusions of this report are based on a review of past studies, interviews with current forest industry operators and interests, as well as with provincial and regional experts in forest management, fiber supply planning, timber supply modeling, manufacturing, and investment planning.

We are requesting your input on the recommendations outlined in Table 18 of the

attached report giving consideration to:

- Whether the recommendations are sound (are data and assumptions complete/accurate?)
- Prioritization of the recommendations
- Opportunities to leverage related provincial projects/priorities and how Skeena Region/CMD can provide input/support
- Implications of delaying these projects on upcoming TSRs and timber disposition decisions within CMD or elsewhere (GBR)
- Next steps (communication plan and action plan) e.g. who are key audiences who should see this report? Who needs to be directly involved in implementation of the recommendations?

On Friday May 13th from 9am-noon, Silverwood Consulting will be giving a presentation on the highlights of this report and offer an opportunity for Q&A. We will set this up as a Live Meeting to allow staff from your offices to be involved. Advise Tara Salmon, Stewardship Officer, on the appropriate contact in your office for this conversation (and forward the meeting invitation as needed). She is also happy to answer any questions you have about the report.
