The Workshop on Understanding the Sendai Framework at the Provincial Level: Development of Disaster Risk Reduction Strategies and Plans in British Columbia will provide guidance to provincial government staff to develop disaster risk reduction strategies and plans, including the joint mandate deliverable for ECCS and EMCR on a Disaster and Climate Risk Reduction Plan. The workshop is led by the United Nations Office for Disaster Risk Reduction (UNDRR) staff joining us in person from South Korea, Brazil, with support from a virtual collaborator in the United States.
