Pages 55-56, 58-60, 88, 94-98 and 145-152 were not originally provided as they were determined to be outside the scope of FOIPPA, pursuant to section 3(1)(j) - a record that is available for purchase by the public. The remaining pages are available for purchase, and as such do not fall within the scope of FOIPPA.
