I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

*Records that show the legal address or street address of the 55 upland properties on Shuswap, Mara, or Little Shuswap Lake where shoreline restoration is planned; Details of any habitat assessments carried out to prioritize these locations as important for restoring fish habitat*

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 13 (Policy advice or recommendations), 15 (Disclosure harmful to law enforcement), 16 (Disclosure harmful to intergovernmental relations or negotiations), 17 (Disclosure harmful to the financial or economic interests of a public body), 21 (Disclosure harmful to business interests of a third party) and 22 (Disclosure harmful to personal privacy) of FOIPPA.
