FYI - The organizer called me to discuss.

I advised that LCLB's approach to large regional events such as Grey Cup, Stanley cup, Festival of Lights was to not approve licence extensions or special occasion licences that effectively increase the number of licensed seats at or in the area of high risk events, in order to mitigate and reduce the availability of, levels of intoxication from and problems associated with alcohol. His response was essentially that from their perspective the event was separated in location/distance (Sunset Beach versus English Bay), time (only goes to 6 and fireworks starts at 10) and demographics (Rogue Folk Fest attracts older demographic) from the fireworks, so was not a beer garden associated with and would not affect the festival or contribute to intoxication or issues for the police or other agencies. I expect that is the case that he will be making to the Parks Board, VPD and CoV, as well as to LCLB.
