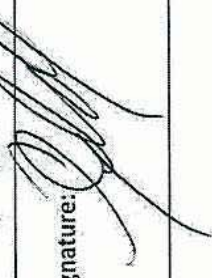

Dear Colleagues,

It is my understanding that you are leading a review into the planning and activities that precipitated the riots following Game 7 of the Stanley Cup final in Vancouver, on June 15, 2011.

With this express mandate, I also understand that the focus of your review will not include a review or solicitation of public complaints related to specific conduct of members of the Vancouver Police Department and other police services deployed from outside of Vancouver to assist in the Vancouver Police Department's operation on the night in question.

The Commission for Public Complaints against the RCMP (CPC) is an independent agency created by Parliament to ensure that public complaints made about the conduct of RCMP members are examined fairly and impartially. In fulfilling this role, the CPC is mandated to receive complaints from members of the public concerning the conduct of RCMP officers. It may be of interest to you to note that the CPC has received no complaints to-date with respect to RCMP member conduct during the riots.

I would invite you to contact me at your convenience should you wish to discuss the mandate and role of the CPC, or if you have any substantive issues for which the CPC may provide assistance.

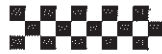
