#### Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Public Safety and Solicitor General. Your request is for:

# Any records outlining the number of times a cell is used for separate/solitary confinement each year in BC Provincial institutions, whether it be for long term or short term, in any given time frame (e.g. Monthly report). Any records with recommendations regarding separate/solitary confinement, segregation or double bunking. The timeframe is January 1, 2001 to present.

On March 9, 2012, we advised that the portion of your request that relates to BC Corrections is not readily available and would require research and analysis to compile. As such, the Corrections Branch suggested you submit a research application, which was provided to you along with the contact information.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 13 (Policy advice or recommendations), 14 (Legal advice), and 15 (Disclosure harmful to law enforcement) of FOIPPA.
