

ADVICE AND RECOMMENDED RESPONSE:

- As soon as the Province was made aware of the situation, staff deployed to the Provincial Emergency Coordination Centre to begin obtaining details, requesting and providing information as they could.
- The information provided to the province comes from the West Coast and Alaska Tsunami Warning Centre.
 The Centre's website incurred technical issues delaying the ability for BC to confirm many details.
- In emergencies, accurate information is paramount to public safety; a hasty response with potentially inaccurate information can lead to greater safety risks.
- Emergency-Info-BC is managed by two staff, they engaged immediately upon notification and as soon as trusted information was obtained, it was relayed.
- The first EMBC blog post was 8:45pm and tweeted at 8:55pm. In the lead up to that, staff advised the public they were working on getting accurate information.
- As soon as one could technically be convened and experts made available to answer questions, a media conference call was held to provide updated information and the call's recording was posted online.

KEY FACTS REGARDING THE ISSUE:

There were criticisms on the delay in information available online about the earthquake and tsunami alert. The EMBC online communication team (2 FTE's, unpaid overtime) were among the very first to respond to the event and self-deploy, however, it was 50 minutes before proper analysis of the information collected could be done and thereby relayed to the online public.

Eleven tsunami bulletins were issued by WCATWC for this event. Based on this information, EMBC has issued five tsunami notification bulletins through the Provincial Emergency Notification System (PENS) to emergency management stakeholders and the media. A total of approximately 4800 voice calls, 4500 e-mail and 1600 faxes were issued. Some of these calls were reportedly delayed due to congestion and potentially because of power and telecom outages.

The Provincial Emergency Notification System (PENS) is the primary method of notification to designated parties within the coastal communities affected by the tsunami warning. Emergency Info BC is a public facing mechanism for information sharing of confirmed, accurate information through online channels.

EARTHQUAKE BACKGROUND

An earthquake of magnitude 7.7 (originally determined to be 7.1) occurred off the coast of Sandspit BC at 2004 hours October 27, 2012. An initial tsunami warning for the coastal areas of BC from the north tip of Vancouver Island to Alaska (including the North Coast and Haida Gwaii, as well as Bella Bella, Bella Coola, and Shearwater) was issued by the National Weather Service West Coast Alaska and Tsunami Warning Centre a short time later. The outer west coast of Vancouver Island (from Cape Scott to Port Renfrew and Juan de Fuca Strait from Jordan River to Greater Victoria including the Saanich Peninsula) were subsequently placed under a tsunami advisory.

ADVICE AND RECOMMENDED RESPONSE:

- We have a robust and multi-faceted emergency management system in British Columbia, one that is recognized globally for its efficiency and effectiveness.
- While much of the public and media focus has been on social media, it's critical to remember that it is just one part of what is a comprehensive notification system.
- Last weekend, we saw the leadership of local authorities up and down the coast as they activated their emergency action plans.
- I also believe our operational team at Emergency Management BC (EMBC) responded quickly and worked diligently to keep the public informed.
- This is not to suggest there aren't aspects of the response that can't be done better.
- Like all other significant seismic events, EMBC will analyze and debrief to identify any areas of potential improvement and ensure continuous improvement for our organization.

IF ASKED about response time:

 As is the case when any earthquake happens and there is the potential a tsunami may impact British Columbia's coast, the first official notification came from the West Coast and Alaska Tsunami Warning Centre (WCATWC) in Alaska.

- This notification came directly to EMBC as well as to the many local governments, agencies, media and individuals who are registered with the WCATWC notification system.
- As is appropriate, many local authorities began acting as soon as they received this initial notification.
- As the next step to further increase awareness of this notification, EMBC staff then began using a variety of tools to relay this critical emergency information to local governments, media and key stakeholders.
- In fact, within 12 minutes the Emergency Coordination Centre (ECC) had began directly calling provincial emergency management staff and local authorities in the impacted regions.
- In addition, as for our overall response, Minister Bennett and other ministers were calling local mayors almost immediately to commit our government's support for anything they needed.
- Our first priority in these situations is to contact first responders and those who will lead the local emergency response, and then to let them take over and decide how best to contact the citizens of their communities.

IF ASKED about online response:

 The staff behind our @EmergencyInfoBC twitter feed will always be working to find that right balance between accuracy and timeliness in how we post social media updates.

- At the end of the day, the fact remains if Mother Nature has let you know there is a problem, please don't wait for your cell phone to ring, or to get a text or Twitter message; move into emergency mode and activate your plan.
- I can assure you that Emergency Info BC staff engaged immediately and reached out to acquire trusted, accurate information to relay to British Columbians
- I also understand that the Tsunami Warning Centre's website incurred technical issues that delayed our ability to confirm many details.
- In addition, as soon as one could technically be convened and experts made available to answer questions, we held a media conference call to provide updated information and the call's recording was posted online.

KEY FACTS REGARDING THE ISSUE:

There were criticisms on the delay in information available online about the earthquake and tsunami alert. The EMBC online communication team (2 FTE's, unpaid overtime) were among the very first to respond to the event and self-deploy, however, it was 50 minutes before proper analysis of the information collected could be done and thereby relayed to the online public.

Eleven tsunami bulletins were issued by WCATWC for this event. Based on this information, EMBC has issued five tsunami notification bulletins through the Provincial Emergency Notification System (PENS) to emergency management stakeholders and the media. A total of approximately 4800 voice calls, 4500 e-mail and 1600 faxes were issued. Some of these calls were reportedly delayed due to congestion and potentially because of power and telecom outages.

The Provincial Emergency Notification System (PENS) is the primary method of notification to designated parties within the coastal communities affected by the tsunami warning. Emergency Info BC is a public facing mechanism for information sharing of confirmed, accurate information through online channels.

EARTHQUAKE BACKGROUND

An earthquake of magnitude 7.7 (originally determined to be 7.1) occurred off the coast of Sandspit BC at 2004 hours October 27, 2012. An initial tsunami warning for the coastal areas of BC from the north tip of Vancouver Island to Alaska (including the North Coast and Haida Gwaii, as well as Bella Bella, Bella Coola, and Shearwater) was issued by the National Weather Service West Coast Alaska and Tsunami Warning Centre a short time later. The outer west coast of Vancouver Island (from Cape Scott to Port Renfrew and Juan de Fuca Strait from Jordan River to Greater Victoria including the Saanich Peninsula) were subsequently placed under a tsunami advisory.

VICTORIA - Saturday night's earthquake near Haida Gwaii serves as a reminder to all of us just how important it is to be prepared for emergencies. In the days since this event, a number of questions and concerns have come forward around how and when communities received tsunami information from the B.C. government.

We have a robust and multi-faceted emergency management system in British Columbia, one that is recognized globally for its efficiency and effectiveness. While much of the public and media focus has been on social media, it's critical to remember that it is just one part of what is a comprehensive notification system.

I know that last weekend, in response to the earthquake, the system worked well at the local-authority level and our operational team at Emergency Management BC (EMBC) responded quickly and worked diligently to keep the public informed. This is not to suggest there aren't aspects of the response that can't be done better.

On Saturday, as is the case when any earthquake happens and there is the potential a tsunami may impact British Columbia's coast, the first official notification came within minutes from the West Coast and Alaska Tsunami Warning Centre (WCATWC) in Palmer, Alaska. The WCATWC sent this notification to EMBC as well as to the many local governments, agencies, media and individuals who are registered with the WCATWC notification system. As is appropriate, many local authorities began acting as soon as they received this initial notification.

As the next step to further increase awareness of this notification, EMBC staff then began using a variety of tools to relay this critical emergency information to local governments, media and key stakeholders. In fact, within 12 minutes the Emergency Coordination Centre (ECC) began directly calling provincial emergency management staff and local authorities in the impacted regions.

Local authorities are the first responders in B.C.'s communities and are required by legislation to have emergency plans in place that include procedures for relaying critical emergency information to residents and visitors.

The initial tsunami notification from the ECC also went to senior levels of government, representatives from the military and Public Safety Canada, RCMP, utilities and BC Ambulance. Last weekend, we saw the leadership of local authorities up and down the Coast as they activated their emergency action plans.

One of the other majors tools government uses to contact British

Columbians directly is the Provincial Emergency Notification System (PENS). This was added in 2006 as part of our earthquake and tsunami response plan and uses technology to systematically send tsunami notifications via phone, fax and email to thousands of first responders, local governments and the media.

Our government will do everything we can to notify as many people as possible. Our first priority is to contact first responders and those who will lead the local emergency response, and then to let them take over and decide how best to contact the citizens of their communities.

The staff behind our @EmergencyInfoBC Twitter feed will always be working to find that right balance between accuracy and timeliness in how we post social media updates, but at the end of the day, the fact remains - if Mother Nature has let you know there is a problem, don't wait for your cellphone to ring, or to get a text or Twitter message. Move into emergency mode and activate your plan. Especially if we're facing a large earthquake or other disaster, your Internet or cellphone access may be limited and it will be your initial response that saves your life.

The most important thing for people in coastal areas of B.C. to understand is that when the ground shakes - especially if it goes on longer than a minute - that's the first notification that a tsunami could impact the area. Anyone in coastal locations who feels strong shaking from an earthquake should assume that a tsunami may have been generated and should immediately move to high ground as soon as the shaking stops.

We must never forget that emergency preparedness begins with each of us as individuals. All British Columbians should have emergency plans and kits in place for themselves and their families. You can find out how to create your own emergency kit at: http://goo.gl/fNFa3

And all British Columbians should take the time to familiarize themselves with their community's emergency plan.

As with any large emergency response, I have asked EMBC to conduct a review of how our response and communications systems worked. It's only responsible that we continue to look at not only what went right, but more importantly, where we can improve and how we can better work with our emergency response partners in local communities to notify and protect our citizens.

I can reassure British Columbians that our government is committed to providing a world-class public safety response.

I have these, more detailed maps (with more community and FN community names).

I could still create a table for you, but it would take some time/effort and require an idea as to what size community you'd like on it.

Also, people should go to their local governments to find out their level of risk... the maps DO NOT reflect risk, except at the most general level. They are solely meant for notification of tsunami alerts. There is no tsunami modeling done for BC, except in Tofino, Ucluelet, Port Alberni and some areas of the CRD.

Let me know if these maps suffice.
