Hi Sue,

Here's the information you requested... the correct number is 21 dam removals since 2006.

Providence dam: location, age, size, type and function, current state of repair before removal etc.

Providence Dam/Marshall Lake is located eight kilometres from the southern B.C town of Greenwood. The dam is 155 metres long and 9.1 metres high. The Ministry of Forests, Lands and Natural Resource Operations holds two water licences on the dam for a total of 266 acre feet of storage. This structure was built as a wood-and-timber in the 1930s. It was reconstructed as an earth-filled dam in 1961 by the Phoenix Mining Co., and again in 1966/67 (using rock) to its current height of 33.5 feet to supply water to the now-defunct Phoenix mine, which closed in 1976.

Since then it has served mainly as a recreational site for area residents. In June 2010, after the Testalinden Dam breach, the Province conducted inspections on all of its dams. During this inspection on the Providence Dam a number of concerns were identified by the Ministry which warranted further investigation. A dam safety review was subsequently completed in December 2010 which identified a number of management concerns.

Who currently owns the dam?

It is owned by the Okanagan Fisheries Section of Forest, Lands and Natural Resource Operations

When and why may the decision for removal be taken?

The decision to decommission the dam was made earlier this year after the City of Greenwood formally declined the opportunity to assume responsibility for maintenance, upkeep and associated liability. The Kootenay Boundary Regional District had declined this opportunity earlier. The decision was prompted by safety concerns related to the condition of the aging structure. Draining of the lake is taking place this winter with decommissioning slated for the spring/summer of 2013.

Is this related to safety issues?

Providence Dam is classified as a 'high consequence' rock filled dam. This classification is based on the potential for loss of life, substantial economic & social loss (e.g. damage to infrastructure, houses, public facilities), and significant environmental and cultural loss (deterioration of provincially important fish, wildlife, ecosystem habitat) in the event of a dam failure. Providence Dam does not currently meet the Provincial Dam Safety Regulations or the Canadian Dam Safety Association (CDA) standards. A significant amount of work would be required in order to meet current regulations and ensure public safety.

Please give details about the involvement of the City of Greenwood. Did they propose to take over maintenance of the dam to prevent decommissioning and removal? What has been decided?

In early 2011, ministry staff met with officials from Greenwood and gave local government a year to explore the option of transferring the dam license and liability to local government or the public. The Kootenay Boundary Regional District indicated they were not interested. Staff did not receive a response from the City of Greenwood at that time. In May 2012, ministry staff made another presentation and there was also a site visit to Marshall Lake. The deadline for a formal response was set for the end of the June 2012. This was further extended to July 13, 2012, when the town formally declined the opportunity to assume responsibility for this dam.

Have you been involved in other dam removals or are any planned for the future? Please give brief details about the projects involved, state of repair and reasons for removal.

Since 2006, the province has over seen the removal of 21 dams, some of which were owned by the province and some of which were privately held. Dams are most often decommissioned or removed when they no longer meets the needs of the dam owner and/or when the dam has deteriorated to the point that it is no longer safe and the cost of repair or replacement exceeds the benefit.

Four major dams (over nine metres in height) have been removed since 2006. They are:

- a) Heber River Dam (near Campbell River on Vancouver Island) Removed in 2012. This dam was removed as part of the Water Use Plan for the Campbell River system.
- b) Mavis Lake Dam (Greater Victoria on Vancouver Island) Removed in 2007. This dam was removed because the cost for repair or replacement exceeded its benefit.
- c) Jack Lake Dam (Greater Victoria on Vancouver Island) Removed in 2007. This dam was removed because the cost for repair or replacement exceeded its benefit.
- d) Upper Greyback Dam (near Penticton) Removed in 2006. This dam was removed because the cost for repair or replacement exceeded its benefit.

In British Columbia, dam owners wanting to remove their dam must conform with the <u>British Columbia Dam Safety Regulations</u> under the *Water Act*. Removal or decommissioning of dams is the responsibility of the dam owner.

Some details about decommissioning plans for Providence Dam (Marshall Lake).

The water level in the reservoir was previously lowered and this fall will be further lowered to the level of the original lake prior to dam construction, alleviating the public safety risk as well as the liability and long-term maintenance costs to the province. The resulting lake will be 7.7 metres deep and continue to be stocked with rainbow trout to support a recreational fishery and ecosystem values. The Ministry's Regional Fish & Wildlife staff are preparing to submit a decommissioning plan to the Sr. Dam Safety Officer. Until the plan is received an approved, decommissioning cannot proceed. It's anticipated that decommissioning would not happen until Spring 2013 at the earliest.

Hi Shara,

Further to our conversation on Friday here's an update on plans to decommission Providence Dam at Marshall Lake.

After a thorough evaluation, ministry staff opted for a partial draining of the lake that will ensure public safety and leave about seven metres of water to maintain recreation opportunities. Plans call for the installation of a dock to facilitate recreational fishing access.

Funding set aside for this project is \$200,000. Estimates indicate a complete removal of this dam would cost at least \$750,000

This work is slated for completion in late August and September. Contracts for this work are being finalized this month.
