Re: Richmond Olympic Experience

It is my pleasure to introduce the Richmond Olympic Experience (ROE). The ROE is one of only 22 International Olympic Committee endorsed Olympic and sport museums in the world and is the first to be located in North America. This exciting project will provide 16,000 square feet of dynamic museum and interactive displays throughout and immediately outside the Richmond Olympic Oval and will integrate best practices from the most dynamic and inspirational museums.

The total confirmed capital (cash) budget for the ROE project is \$6.86 million, not including anticipated grant funding from Heritage Canada (application is presently in process) in the amount of \$500,000 or the matching \$500,000 grant we presently seek from the Province of British Columbia. Due to the number of funding contributors, the \$6.86 million ROE project budget has been divided into three funding categories:

Cash from the City and Oval Corporation: \$1.207 million i.

Cash from commercial sponsorships and bourism: \$4.785 million/ ii.

Value in Kind from the International Olympic Committee (IOC) and Canadian iii. Olympic Committee (COC): (estimate) \$3 - \$4 million

Approval of the grant applications at \$500,000, each submitted to the Province of British Columbia and Government of Canada respectively, and additional sponsorship funds, will ensure the ROE project achieves the target budget goal of \$8 million, in addition to, and therefore ensuring that we are able to fully leverage the significant level of Value in Kind

already committed to the project by the IOC and COC.

The ROE project is presently in the design and construction phase with the anticipated opening in late 2014.




Introducing the Richmond Olympic Experience - Coming Fall 2014



The entire experience will encompass over 15,000 square feet of space throughout the Richmond Olympic Oval's three levels including part of its outdoor surrounding grounds.


The vision to keep the Olympic Spirit alive will be through a transformative exhibit experience that inspires excellence in sport, promotes community and motivates all to dream big. Visitors to the Richmond Olympic Experience will be taken on a journey of transformation as they follow the pursuit of the Olympic dream in a multi-media theatre; before continuing through a series of multi-media galleries celebrating Olympic history and Richmond's rich sporting heritage; and learn about the ideals of the Olympic Movement. Exhibits will feature hundreds of artefacts collected from Olympic and sport athletes including a collection of Olympic torches and medals. Visitors can also feel what it is like to fly off an Olympic ski jump, sit in the cockpit and drive a Formula 1 race car, test soccer and jumping abilities, and experience other thrilling, interactive sport simulations. Other features will allow visitors to explore Olympic and sport history on touch tables and data lounges; get a picture of themselves with an Olympic athlete; learn what lies ahead for the next Olympic host nation; celebrate the thousands of volunteers that helped host the Olympic Winter Games in 2010; and enjoy a commemorative Torch Relay trail along the Richmond Olympic Oval's outdoor plaza and surrounding grounds.


