Thank you for your letter regarding the Northern Opportunities Program, delivered in School Districts 59, 60 and 81, which is one of a number of successful student transition models in British Columbia.

I understand that the former Minister of Advanced Education, the Honourable Ralph Sultan, directed staff from my ministry to arrange a meeting to discuss the Northern Opportunities Program with staff from the Ministry of Education (EDUC) and the Ministry of Jobs, Tourism and Skills Training (JTST). A key priority under my mandate as the Minister of Advanced Education is to work closely with JTST and EDUC to ensure the integrated delivery of education and skills training to support high school students in successfully entering the workforce.

As you may be aware, there are a number of other successful student transition models in British Columbia that are funded by their partner organizations, rather than by Government. These include Thompson Rivers University's TRU-Start program, and the South Island Partnership program that involves Camosun College, the five school districts of southern Vancouver Island, and local industry. Another example is the Career Technical Centre in Prince George, that is a partnership between the College of New Caledonia and School District 57, which enables high school students to get a head start on apprenticeships in fields like automotive service repair, carpentry, plumbing and many other trades.

As well, Northwest Community College recently signed the Coastal Pathways Partnership agreement with Terminals Inc. and School District 52. The five-year partnership will provide an investment of \$350,000 toward delivering skills training, specifically targeting the needs of the region. The agreement will facilitate early exposure to training and employment opportunities for high school students; cooperation with industry to enhance the learning environment for all students; and, trades training that will provide citizens in the region with long-term employment.

As you know, the Government of British Columbia has announced its budget and funding priorities for 2013/14, and there is a strong commitment to balancing the provincial budget. Given the challenging fiscal environment, the Ministry of Advanced Education is unable to commit to providing \$300,000 in ongoing funding to support the Northern Opportunities Program.

The Northeast Regional Workforce Table was established by JTST to address the type of challenges you describe and to bring local stakeholders together to discuss how best to align regional training to meet local employment opportunities.

As this matter also falls within the responsibility of Honourable Shirley Bond, Minister of Jobs, Tourism and Skills Training, and the Honourable Peter Fassbender, Minister of Education, I am sharing your letter with Minister Bond and Minister Fassbender for their consideration.

The provincial government controls the level of tuition fees charged to students in our universities and colleges. In the years prior to election of the new government in 2001, tuition fees were fixed by government -- presumably to garner favour with students and their families — with the result that these institutions were, with inflation on-going, increasingly squeezed financially.

For about two years under the Gordon Campbell government, price control was abolished. Universities and colleges moved tuition rates up briskly (with no discernible slackening of demand).

In September 2005, the Campbell government reinstated price controls under the Tuition Limit Policy to garner favour with students and their families. Tuition fees could be increased 2% per annum maximum. Most institutions appear to have adopted the maximum 2% cap per annum.

As university costs climb, particularly at professional schools such as engineering and medicine, subject to international competition for faculty, many universities once again feel the financial squeeze. This squeeze will not relax under the stringent budgeting discipline of Budget 2013-14 and beyond.

Recently, a faculty member from the Faculty from which I graduated many years ago at UBC, the Faculty of Applied Science, approached me with a suggestion to provide professional schools with a measure of budgetary relief.

His suggestion was:

Selected professional faculties at B.C. universities should be allowed to raise their tuition levels by 5% per annum, subject to the condition that 1.5% – that is, one half of the 3% increment over the previous allowable increase -- is turned back to the students in the form of bursaries.

The faculties which would be permitted to adopt this new pricing cap would be Medicine, Dentistry, Pharmacy, Applied Science (including engineering and nursing), and Forestry. All other university divisions would remain under the 2% tuition cap.

A compelling reason for allowing such increased flexibility in setting tuition rates is the fact that Engineering at UBC, as one example, is falling farther and farther behind competing quality institutions in its tuition rates; for example (full year tuition rate for undergraduate students taking a normal course load):

We rank some of the best North American engineering schools from most expensive to least expensive:

MIT	\$42,050	US dollars (higher in Canadian dollars)
Caltech	\$39,990	US dollars (higher in Canadian dollars)
Texas A & M	\$9,006	US dollars (higher in Canadian dollars)

UC Berkeley	\$7,492.75	US dollars (higher in Canadian dollars)
Queen's	\$11,935	,
Waterloo	\$11,600	•
Toronto	\$11,354 to 12,363	
Alberta	about \$6,600	
UBC	\$5,593 to \$6,000	

Note that private American engineering schools charge up to seven times higher engineering tuition that does UBC. Even the three state universities in the above list, charge significantly higher tuition than UBC. Ontario engineering schools charge about twice as much for their tuition as does UBC.

Conclusion: UBC is under pricing its engineering tuition significantly. As measured by the competition, there is significant scope for UBC to increase its tuition, particularly when offset by increased bursary assistance for students in need.

Minister, our universities live in a competitive world. If, for misguided political reasons, we force our universities to charge much lower tuition than the market dictates, there are two consequences: the burden on the general taxpayer of British Columbia is increased, and the burden on our institutions striving to be the best, is increased.

I believe this proposal warrants serious consideration.

I thought you and the rest of the government would be interested in this. The majority of these jobs are in the private sector. I believe it is time to look at a second Physio School in BC as many qualified students have to go elsewhere and never return and many of the jobs sit empty.

The UBC school would argue differently as they want to keep control but in todays information world you do not have to have a school of medicine attached. At one time much of the lectures were from medical faculty but not so any more. The private sector jobs are outstripping the public sector by a huge margin. At one time 30 years ago s.22 there were approximately 200-300 private physios out of about 1700. Now there are about 1600 out of 3200 registrants. So a 50% split between Private and Public

In the job creation area it would be a boost to have a second school and i would encourage some of the other universities such as Quest to look at it. Yes the tuition would be high but the job market is there after in all areas. The baby boom bulge is going to put a strain on all Public facilities and I can attest to the fact people are will ing to pay for private physio. It is efficient, effective and keeps people out of the hospital system.

Think about it and I do think that is worth the government looking at. We should be graduating 150-160 a year to keep up with demand and these numbers growing to 200 over the next 10 - 15 years. I do not think expanding the UBC system is efficient or desirable, it already is caught in efficiencies of staffing. Many of the courses are supported by external clinical staff. They will argue no practical placements and I would say it is because they are poor at public relations and placing students.

Thank you for your correspondence shared with Ms. Jackie Tegart, MLA for Fraser-Nicola. regarding the Private Career Training Institutes Agency (PCTIA) filing requirements for \$5.22 As this matter falls within the responsibility of the Honourable Amrik Virk, Minister of Advanced Education, your request has been forwarded to me for response on Minister Virk's behalf.

While the Province of British Columbia is responsible for the legislation that governs private career training in British Columbia, Government does not directly oversee private career training institutions. As you know, these institutions are regulated by PCTIA, a Crown Agency created by the Province under the authority of the *Private Career Training Institutions Act* (the Act).

With regard to your concerns on documenting projected cash flow of all programs delivered by a private career training institution, I can advise you that the requirement for a *Projected Cash Flow* Statement is part of the PCTIA bylaws, and has been enacted for sound reasons. All private career training institutions have the same requirements to submit the *Projected Cash Flow Statement*, as it is an important method of determining the financial stability of an institution and assists PCTIA with its legislative mandate of providing consumer protection for students. As a regulatory agency, PCTIA is expected to treat the private institutions under its regulatory scope in a fair and equitable manner, and bylaw requirements must be applied equally to all private career training institutions registered with PCTIA. I understand from your correspondence that you were granted an extension by PCTIA staff. You may wish to contact PCTIA to discuss your concerns on this matter further.
