

- In July 2011, the Province, six regional health authorities, BC Hydro, WorkSafeBC, the Insurance Corporation of BC and the BC Lottery Corporation signed a 10-year, \$1 billion contract with TELUS that provides government long distance, conferencing, voice, data, and cellular services.
- As a result of the contract, the non-monetary Connecting BC Agreement was signed, which focused on expanding broadband and cellular connectivity to support economic and social development in rural and remote communities.
- Existing targets in the Connecting BC Agreement include:
 - Increasing broadband connectivity to 97% by 2021 in TELUS' current service area.
 - Providing 1,716 kilometres of new cellular coverage along unconnected highway segments by July 2016 to improve public safety.
- Since 2001, the provincial government has invested an estimated \$50 million and the federal government has invested an estimated \$100 million. These investments together with leveraging opportunities (i.e., TELUS Deal) have increased access to broadband from 82% to over 93%.



Attachment 3 - Network BC's Estimate for Accelerating the CBCA Connectivity Targets

This attachment describes the approach used by Network BC to further refine the cost estimate to accelerate the CBCA connectivity targets. The approach was based on data collected by Industry Canada and the CRTC. This data was organized by dissemination blocks or "HEX's" which had information about the number of people with access to the Internet, the speeds and type of technology for that block.

Industry Canada's new definition of broadband was used which is 5MBps upload and download. Thus people who had access to either DSL or cable service were considered to have access to broadband connectivity. People who had access to fixed wireless required an upgrade. People who had neither access to DSL nor cable were considered unconnected. These people would require both local connectivity (equivalent to an upgrade) and backhaul from their geographic location to a location that had connectivity already.

Network BC constructed a financial model that (1) identified HEX's that required upgrades to local connectivity, (2) HEX's that needed net new backhaul and (3) HEX's that were already broad band connected. HEX's were classed according to a minimum of how many people were not connected in the HEX. For example in the table below there is a row entry of a minimum of more than 10 people not having broadband access. That means that there could be 11, 12 ... and so on people not having access to broadband in a HEX that meets this criteria. HEX's that only have 10 people in them would also not be selected.

The table below shows three scenarios: (1) where the threshold is 100 people unconnected, (2) 10 people unconnected and (3) everyone connected. Column 2 shows the total number of fiber kilometers needed to connect the HEX's. Column 3 shows how much of the current unconnected population (204,902 people) would be served by the acceleration. Column 4 shows how that would advance the metric of percentage of British Columbians with a broadband connection. Column 5 identifies the capital costs associated with the backhaul (fibre). Column 6 shows the cost of upgrading the local last mile within a HEX.
