PURPOSE: For INFORMATION for the Honourable Suzanne Anton, QC Attorney General, Minister of Justice

ISSUE: Background information on DriveABLE program for December 4, 2014 Meeting with Minister Anton

SUMMARY: Provides background information on:

- Related demographics, driving and cognitive decline
- Current cognitive assessment review work underway

BACKGROUND:

RoadSafetyBC's Driver Fitness Program is responsible for assessing drivers and making driver fitness decisions. One of the highest risk groups being assessed are those drivers aged 80+. Aging drivers are a high-risk group of drivers due to the increased possibility of medical conditions. In British Columbia between 2008 and 2012, there was an annual average of 9,300 collisions involving drivers age 80 and older.

The risk level of the aging driver population further increases for those who have cognitive impairments. In BC, RoadSafetyBC uses DriveABLE to functionally assess those drivers who have been identified as having cognitive impairment.

Current Cognitive Assessment Review Work Underway

Driver cognitive assessments are an important part of RoadSafetyBC's Driver Medical Fitness program area. The majority of these assessments are conducted on senior drivers.

Currently, the driver fitness cognitive assessment process is managed in BC through a contract with Insight Driving Solutions ("Insight") for the delivery of DriveABLE services (both in-office and on-road tests). This contract is for a three year term until March 2016, with the option of two additional extensions of 12 months each.

ISSUE:

Meeting with MLA Nicholas Simons regarding Driver Medical Fitness

BACKGROUND:

Approach to Conducting Assessments

The Office of the Superintendent of Motor Vehicles (OSMV) is responsible for assessing drivers and making driver fitness decisions. The primary tool used for this assessment is the Driver's Medical Examination Report (DMER), completed by a driver's physician – it helps to assess whether there is a medical condition and/or functional impairment and, if so, the severity, progression, treatment or effects of any medical condition(s) and/or functional impairment that could affect fitness to drive.

There are generally three situations that may result in having a DMER completed: 1) a routine assessment based on age or class of driver's licence; 2) routine assessment due to a known medical condition (e.g., diabetes); or 3) an unsolicited report, generally from the police or a person's physician.

The current requirement is that all drivers 80 years of age or older have a DMER completed every 2 years. This is a routine assessment for all medical conditions that may affect a senior's ability to drive. It is not a 'mandatory cognitive assessment' as noted in MLA Simons' letter dated October 21, 2013. However, if during a routine assessment a physician suspects that a driver may have cognitive issues that could affect their driving, then some form of basic cognitive testing will be done. Results from screening tools such as the Mini-Mental Status Exam (MMSE), Montreal Cognitive Assessment (MoCA) or Screen for the Identification of Cognitively Impaired Medically At-Risk Drivers (SIMARD) are reported by the physician on the DMER (see Attachment 1 for a flow chart of cognitive assessment). If conditions are noted on a DMER that may affect the person's fitness to drive, OSMV makes a case by case determination of the person's driving status.

These determinations are based on the 2010 BC Guide in Determining Fitness to Drive (the Fitness Guidelines) and although the Guide specifically references the use of the SIMARD, OSMV will accept results from any of the accepted cognitive screening tools

the physician determines to be appropriate. Where further information is required, OSMV takes various actions to obtain that information, generally in the form of individual assessments. For example, OSMV may require a vision test, a functional driver cognitive assessment using DriveABLE methodology, a standard ICBC driver road test, or additional medical examination information from a specialist.

The Fitness Guidelines were developed through five years of extensive research and consultations with the medical and scientific community and in collaboration with the BC Medical Association (BCMA).

Use of DriveABLE

DriveABLE was introduced in British Columbia in 2005 following a 1999 Supreme Court of Canada decision that held that OSMV must individually assess drivers according to the driver's personal abilities rather than presumed group characteristics. DriveABLE was perceived to be the only commercially available methodology that assessed cognitive functions specific to driving.

Prior to the introduction of DriveABLE methodology, OSMV relied on medical diagnostic reports to determine a driver's fitness to drive in relation to cognitive functioning. However, there were concerns that this approach did not meet the Court's requirement to individually assess a person's ability to drive.

A Driver Fitness Payment Policy was also established as a result of the Supreme Court decision and British Columbia Human Rights Tribunal decisions.

In 2010, OSMV established a relationship with the BCAA Road Safety Foundation, a non-profit organization and existing road safety partner, to provide DriveABLE services. This allowed government to directly pay the DriveABLE assessment fees on behalf of the client. In addition, the BCAA Road Safety Foundation volunteered to coordinate appointment and scheduling processes, as well as administrative services for British Columbia's DriveABLE centres.

In January 2012, BCAA Road Safety Foundation chose not to continue with its coordination role and gave up its licenses.

s.22 obtained the

DriveABLE licence and the contracts with service providers to deliver DriveABLE services across the province. This was done through a newly formed organization called Insight Driving Solutions (Insight). OSMV used Insight to perform assessments, on a fee for service basis.

In response to concerns raised by some seniors about the DriveABLE program, a decision was made by Minister Shirley Bond in March 2012 to enhance the way the program was being delivered. Included in this enhancement was:

- an expansion from the existing 17 service locations to the current 28 (several in remote towns with low demand for assessments);
- the option for a driver to take a DriveABLE on-road evaluation following a failed in-office assessment;
- the option to bring a companion to the assessment; and
- more flexibility in the time allowed for assessment.

In the interests of evaluating what other cognitive assessment methodologies were available in the market and to establish a formal long-term contract with a supplier, the Ministry launched a competitive procurement process on October 17, 2012.

Insight was the only supplier that met the minimum qualifications stated in the procurement document, and their proposed solution included the use of DriveABLE methodology. A three year contract was established in March 2013 with Insight for the delivery of cognitive assessments in 28 locations across the province.

While DriveABLE garners a lot of attention, very few of the drivers who undergo medical assessment are referred to DriveABLE. For example, in 2012, OSMV processed approximately 143,000 DMERs, but only 3,500 (2.4%) were referred for a DriveABLE assessment. See Appendix 2 for more information on the prevalence of DriveABLE referrals, and Appendix 3 for expenditure information.

Demographic data indicates the number of drivers over 80 is expected to increase significantly over the next 25 years and that senior drivers are likely to be driving longer. In 2012, over 75 percent of drivers (approximately 2,700) referred for DriveABLE assessments were aged 80 or older.

CURRENT SITUATION:

As part of an overall mandate review, OSMV is currently reviewing the Driver Medical Fitness Program, including cognitive assessment.




Appendix 2: Prevalence of DriveABLE Referrals, 2010-2012

In addition to the 3,500 drivers referred in 2012, OSMV also offered the on-road evaluation to an additional 500 drivers that had previously been referred and failed the in-office assessment prior to the changes.

OSMV financial expenditures indicate that approximately 80% of drivers referred in 2011 and 2012 have completed the DriveABLE Cognitive Assessment Tool (DCAT). The graph below shows the age demographics of the 3,518 drivers referred to DriveABLE in 2012 by OSMV (age proportions for previous years are consistent).
