Annual statistics (either by fiscal or calendar year) since either Jan 1, 2000 or April 1, 2000, showing the total number of students hired into coop positions each year, the total number of coop work terms each year (since some students have more than one work term in the same fiscal or calendar year) and the number of coop work terms that were ended prematurely for just cause.
