Re: Hazelnut replant program

Recently I had the opportunity to tour several hazelnut orchards in my riding, which are all suffering from the Eastern Filbert Blight. Hazelnut yields are decreasing over time and in a few years, the trees will be entirely dead.

I would note that the hazelnut is classed, in botanical terms, as a fruit, belonging to the *Betulaceae* or Birch family of trees. Unfortunately, hazelnuts are not currently on the list of eligible fruits in BC's BCFGA Tree Fruit Replant Program.

I would point out that hazelnuts are a profitable industry with great value-added potential. Moreover, climate does not allow hazelnuts to be grown elsewhere in Canada; they are grown almost exclusively in the Fraser Valley.

There are varieties of hazelnut from the US which are resistant to fungus, available at a cost. An experimental replant has already commenced, which is progressing well. There would be real benefit to BC agriculture if BC hazelnut producers could take advantage of the existing Replant Program.

I know that this matter is currently under consideration through Mark Sweeney of your Ministry, and I am writing to lend my keen support to this request. Thank you for your early consideration.

Thank you for your recent letter regarding additional information on a potential tree fruit replant program and concerns over the impacts of recent weather events in your riding.

The Province is currently developing a replant program to continue helping tree fruit growers in British Columbia after the current program ends. The objective of the next program will be to assist growers achieve long-term sustainability. The details of the program are still under development and we are in contact with the BC Fruit Growers Association.

As you indicate, growers who replanted before the tree fruit replant program was announced in 2012 were not eligible to receive funding. The program did not provide funding for projects completed prior to the funding announcement.

For more information on the tree fruit replant programs I would encourage you to contact Mr. Jim Campbell, Industry Specialist. Mr. Campbell can be reached by telephone at (250) 498-5254 or by email at Jim.G.Campbell@gov.bc.ca.

With respect to damage to fruit trees from summer hail storms, although the losses for some producers were severe, historical Production Insurance data does not indicate that these events were unique in their severity. The Ministry of Agriculture's Business Risk Management (BRM) programs are available to compensate enrolled producers for losses experienced due to weather related damage.

With regard to accessing additional funding, we do have the AgriRecovery program which can provide support to assist an Agricultural sector to recover from a severe event. We do not, however, have evidence that these recent hail events meet AgriRecovery program guidelines of the Growing Forward 2 agreement. The income losses due to hail are severe but are covered under the Production Insurance and AgriStability programs. Hi Pat,

I am sending my support for the BCFGA request for the renewal of the replant program. I strongly urge you to make this a long term strategy- a minimum of 5 years out.

The replant of 2012 was not covered and some farmers were adversely affected by the abrupt loss of funding after they had ordered the trees. I hope that you are able to address these replant issues.

My riding in particular experienced an unusual weather pattern just prior to the apple harvest this August. The storm was random but severe. It ruined the apples but also caused damage to the trees themselves. Crop insurance will cover the damage to the fruit but it requires the Province to initiate the "disaster" clause for funding to become available to the growers to cover the loss of the trees. Anything you can do to help the farmers affected would be greatly appreciated.

I look forward to hearing from you regarding what the plan is to help relieve our farmers in their time of need and to ensure the future of their replanting needs.

Recently I wrote to you asking that hazelnuts be added to the BC Orchard Replant Program. Hazelnuts are a small but important crop grown in my riding because it is one of the only locations in Canada with a climate appropriate for this fruit. The trees are suffering from Eastern Filbert Blight disease, which has no remedy; the long-term solution can only be to plant resistant and immune varieties.

There is an ongoing provincial Orchard Replant Program, but it does not currently include hazelnuts within its funding parameters. I wrote to you with the request that hazelnuts be included within program definitions so that producers can continue to grow and extract increasing value through further-processing of hazelnuts in the Fraser Valley.

I have since been approached by the Seabird Island First Nation in my constituency, which owns 115 acres (15,500 trees) of Barcelona and Davianna varieties; it is the largest hazelnut orchard in Canada. Given that Seabird is looking for economic development opportunities, I am asking that Seabird be added to the list of growers who could be included in the existing replant program.
