A report identifying all of the completed applications (does not include any pending applications) to transfer location and/or ownership of licensee retail store liquor licences submitted from Jan 1, 2014 to Jan 6, 2015, including the licence number, current and past licensee name, current and past establishment name; current and past address, type of transfer (location or ownership) and distance from past location to current location for transfers of ownership.
