Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. You narrowed your request on November 22, 2012 through conversation and/or email with Scott Carroll. Your request is for:

"Documentation relating to the planning and implementation of BC Tripartite First Nations Health Agreement, specifically how the IFNHA was selected for the grant and how the amount provided was determined."

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 17 (Disclosure harmful to the financial or economic interests of a public body) of FOIPPA. A complete copy of FOIPPA is available online at:

The Ministry of Health has requested that, in addition to the responsive records enclosed with this letter, you also be provided with the following background information with a view to enhancing your understanding of the documentation provided:

• In November 2005, the First Nations Leadership Council, the Prime Minister of Canada and the Premier of British Columbia signed the Transformative Change Accord, which committed all parties to work together to close the gaps in health, education, housing and economic opportunities between First Nations people and the rest of British Columbians. A year later, the *Transformative Change Accord: First Nations Health Plan* was negotiated by the First Nations Leadership Council and British Columbia. In June 2007, the Tripartite First

These two, more detailed plans guide the work of the two levels of government and First Nations in the health sector.

- Funding to support the development and implementation of health actions under these two plans was also negotiated over that period and grants from both the federal and provincial governments were provided first to the First Nations Summit Society and then to the First Nations Health Society when it was established under the *Society Act*. The First Nations Health Society later changed its name to the interim First Nations Health Authority (iFNHA). The Framework Agreement on First Nations Health Governance lays out the funding commitment by both levels of government for the new First Nations Health Authority. British Columbia's commitment is \$83.5 million from 2011/12 to 2019/20. The first \$16.5 million was provided in 2007 and 2008, making the total commitment from British Columbia \$100 million over 13 years. The federal government committed to matching this amount.
- In summary, the iFNHA was created by First Nations to do the work outlined in the two First Nations Health Plans and the Framework Agreement; the government did not select this organization as such. The funding amount provided was negotiated in the context of the Tripartite First Nations Health Plan with the First Nations Leadership Council and the federal government.
