I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Any documents pertaining to the road which between 1927 to 1930 was called the Harrison Agassiz Road RefNo. 40A and which in 1930 was renamed No. 26R Transprovincial Highway (specifically the stretch which starts from the western boundary of the above highway/road which is called as follows in OIC 590/1927: "Westerly Boundary Municipality of Kent at Harrison River Bridge", the stretch from there for about 300 to 500 m to Kennedy Road). Timeframe: from 1927 to 1940.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 22 (Disclosure harmful to personal privacy) of FOIPPA.
