I am writing further to your request received by the Ministry of Advanced Education. Originally you made two requests, AED-2014-00143 and AED-2014-00144, which were very similar in nature to AED-2014-00041 excepting the date range. Due to federal copyright issues this request was not published on the OpenInfoBC website therefore we could not direct you to the website as a resource. You consented to withdraw AED-2014-00143 upon the agreement that the Ministry would provide the records from AED-2014-00041 (provided to you on January 8, 2015) along with responsive records for AED-2014-00144 that encompassed the full date range and nature of your conjoined requests. Your request is for:

“Documents regarding Trinity Western's proposal to establish a law school. Timeframe is June 1, 2014 to December 15, 2014.”
