Regarding The Hemingway Waterfront Public House: A copy of the letter and revised floor plan dated February 3, 2010 that the Branch issued approving in principle the structural change to the establishment; A copy of the final letter of approval issued by the Branch as a result of this structural change application; Any copies of photographs that were taken of the licensed establishment by the Area Liquor Inspector in the Spring of 2010 when they conducted the final inspection of the premises pursuant to the Approval in Principle for the structural change that was approved on February 3, 2010; Any correspondence from the RCMP and Liquor Branch Inspector pertaining to an enforcement incident that happened at this establishment regarding a female minor in the early morning of September 7, 2014 including any correspondence from Constable Brooke Cheney of the RCMP and any emails or correspondence from the Area Liquor Inspector to the Liquor Branch..
