Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice. Your request is for:

Reports, studies, and other pertinent documents supporting and detailing the estimated economic and social impacts of the announced Okanagan Correctional Facility for both the construction and subsequent operating phases including: Documents supporting the economic impact estimates presented in the BC Government's Ministry of Justice December 12 2012 press release 2012JAG0318-002014, Economic benefit estimates for both construction and operating phases including related benefit cost analyses together with their supporting assumptions including assumptions regarding regional distribution of direct and indirect benefits plus related risk assessments; Socio-economic impact data such as perceptual risk, impact of the prison on regional health care facilities and social service agencies etc; Documents supporting the cited estimates including the regional distribution of the estimated benefits.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section(s) 12 (Cabinet and local public body confidences) and 15 (Disclosure harmful to law enforcement) of FOIPPA.

A list of the considerations used to assess the location for the new Okanagan Correctional Centre has been included in this package. Please note that the impact on health and social agencies was not identified as a critical decision-making criteria in assessing prospective sites and that these analyses would be best done directly by those health and social agencies as they have the knowledge and experience to undertake the most in depth analyses of any impacts.
