Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General. Your request is for:

All policies related to the treatment of transgender and/or transsexual people in BC prisons; Description of all training programs for corrections staff related to the treatment of transgender and/or transsexual people in BC prisons; Any records of the number of transgender and/or transsexual people in BC prisons; Any records of the number of transgender and/or transsexual people in BC prisons who have undergone sexual reassignment surgery in BC prisons. Date range is January 1, 1970 to December 1, 2013.

Please find enclosed four pages from the Standard Operating Procedures that respond to your request. These records are provided to you in their entirety. The Ministry has informed me that it does not keep statistics on the number of transgender and/or transsexual people or the number of transgender and/or transsexual people who have undergone sexual reassignment surgery in BC correctional facilities. New Correctional Officers in BC receive Multicultural and Diversity training as well as Professional Ethics and Standards of Conduct training through the Justice Institute of BC (JIBC).
