Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

All documentation generated by the ministry, contractors, employees or other individuals regarding an MVA that took place at or near Highway 99 and East 8th Avenue in Surrey BC on August 20, 2010; and all contracts with respect to highway maintenance for that area; All correspondence with respect to highway maintenance and signage within one mile radius of the accident site from a point in time of 48 hours prior to and after the accident.
