I am writing further to your request received by the Ministry of Health. You narrowed your request on December 30, 2014 through email with Patrick Craib. Your request is for:

Any and all cabinet documents, fact sheets, briefing notes and health position papers that discuss the delisting or deinsuring of pre-travel assessments and immunization services; Additionally, all fee-for-service schedules used as part of the BC Medical Services Plan. Date range is January 1, 1980 to December 31, 1999.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The program area also wishes to communicate that pre-travel assessments and immunization services were never benefits under MSP, and that as such there would be no records discussing delisting or deinsuring such services.
