ADVICE AND RECOMMENDED RESPONSE:

PROJECT MESSAGES:

- We are committed to working with the Capital Regional District to find the best, lowest cost solution for sewage treatment in the region.
- Each year, the Capital Regional District releases more than 40 billion litres of untreated sewage into the ocean. That's more than 126 football stadiums full of sewage every year being pumped into our coastal waters.

 Questions on the Liquid Waste Management Plan (LWMP) and environmental regulatory standards should be directed to the Minister of Environment.

P3/PARTNERSHIPS BC MESSAGES:

- To meet provincial policy related to the planning and management of major capital projects, the Ministry has engaged Partnerships BC to assist in the review of the business case for the CRD's proposed wastewater treatment plan.
- Partnerships BC is evaluating the merits of building this project as a public-private partnership.
- Partnerships BC's mandate is to support public-private partnership projects and to identify options for maximizing the value of public capital assets.
- Partnerships BC's involvement in the project is consistent with their mandate, and supports the funding commitments made by the Province.

IF ASKED ABOUT FUNDING TO PBC:

 As of February 2011, the Ministry of Community, Sport and Cultural Development had paid \$560,785 for the advisory and review services provided by PBC over the last three years. These services are consistent with government's policy on major capital projects.

KEY FACTS REGARDING THE ISSUE:

• On August 25, 2010, the Minister of Environment approved Amendment #8 to the CRD Core Area LWMP. The outcome of this plan is for wastewater treatment by 2016.

 The CRD Board approved the Business Case for the CRD Waste Water Treatment program on March 31, 2010 and recommended a hybrid model combining both P3 and CSC-2012-00102 traditional "public" models for procurement.

- There continues to be significant local media attention on this project, with vocal groups continuing to challenge the need for treatment and P3s.
- Senior governments are committed to supporting this initiative. As part of its funding conditions, the Province will require the CRD to maximize recovery of resources (water, energy, nutrients) from the waste streams, while minimizing costs and greenhouse gas emissions.
- The Province, Canada and the CRD are sharing in the funding of the CRD's program development work, valued at \$10 million (\$3.33 million provincial share). The Province has publicly committed to funding 1/3 of the best, lowest cost solution, subject to P3 consideration. This was done both at UBCM 2006 and in the 2007 throne speech. The federal government has committed to funding 1/3 of the project.

P3s and Partnerships BC:

- All provincially-funded major capital projects in excess of \$50 million must be evaluated by Partnerships BC (PBC) to determine the viability and merit of delivering and financing the project through a P3 agreement.
- Where local government capital projects are involved, the partnering provincial ministry is
 considered the client of PBC and is responsible for paying their advisory services costs.
 The partnering ministry is also responsible for administering related treasury board
 submissions, with procurement-related review and feedback provided by PBC. However,
 the final business case review and recommendations to Treasury Board are the
 responsibility of the partnering ministry and PBC.
- The Ministry engaged PBC in late February 2007 to assist in the review of the CRD Wastewater Treatment Project. The Ministry negotiates its contract with PBC annually.

Project Status:

- The Ministry, the CRD, and PBC are working together to finalize the project and the procurement planning activities.
- CRD communications efforts continue, providing education, outreach, and feedback mechanisms to support the public and FN consultation process. Increased press coverage is expected to continue, with spikes of controversy expected for discussions on the project's procurement strategies (P3s).

Issue: The Association for Responsible and Environmentally Sustainable Sewage Treatment (ARESST) will present their position that the sewage treatment project proposed by the Capital Regional District (CRD) is not appropriate.

Background:

 In July, 2006, the Minister of the Environment, under the authority of the Environmental Management Act, directed the Capital Regional District (CRD) to plan for sewage treatment.

- On August 25, 2010, the Minister of Environment approved Amendment #8 to the CRD Core Area Liquid Waste Management Plan, which outlines how the CRD will provide proper treatment for the 40 billion litres per year of sewage that is being discharged into the ocean.
- The federal government has developed a draft regulation under the federal *Fisheries Act* to manage municipal wastewater effluent across Canada.
 - The standards in the regulation are closely linked to those developed through the national organization the Canadian Council of Ministers of the Environment (CCME), of which The Province of British Columbia (Province) is a member.
 - The provincial Minister of Environment signed the CCME Canada-wide
 Strategy. The standards in the strategy are closely aligned with those already established through British Columbia environmental regulation.

First Nations Considerations: N/A

Discussion:

- Sewage treatment in Victoria has been an issue of public debate for several decades and there are well-established action groups on both sides of this issue.
- Groups who actively pursued sewage treatment for Greater Victoria include Ecojustice (formerly the Sierra Legal Defence Fund), the Georgia Strait Alliance and the grass-roots local group lead by "Mr. Floatie" called People Opposed to Outfall Pollution (POOP).
- There are two, closely-linked local groups actively opposed to the CRD Sewage Treatment project, including ARESST and Responsible Sewage Treatment Victoria (RSTV).
 - ARESST is against the project, proposing the money would be better spent elsewhere and that sewage treatment does not provide the benefits of environmental and public health protection and the resource recovery outcomes, which are being suggested by the CRD.
 - o RSTV claims that there is no need for sewage treatment.
- ARESST identifies themselves as a group of Greater Victoria residents against the sewage treatment program proposed by the CRD.
 - The group is lead by retired local-government and provincial-government politicians and employees and retired engineering and science professionals.
 - o Liberal M.P. Dr. Keith Martin and Dr. Shaun Peck, a retired Deputy Provincial Health Officer, have both given their verbal public support to the group.
- The senior government funding that has been identified for this project was allocated to core infrastructure projects and would not likely have been available for education of health related projects.

Issue: The Capital Regional District (CRD) has requested provincial funding for their sewage treatment project. The Mayor of Esquimalt and the Mayor of Colwood have each requested a meeting with the Minister to share their thoughts on the project.

Additional background on the project is included in the previous October 2010 Update Note and S12

Background:

- The CRD has committed to provide sewage treatment for the core area by 2016, and the Minister of Environment (MOE) has authorized the Liquid Waste Management Plan (LWMP) through which that commitment will be implemented.
- The core area to be served by the proposed sewage project includes the core communities of Victoria, Esquimalt, Colwood, Langford, Saanich, View Royal and Oak Bay. The Saanich Peninsula (North Saanich and Sidney) and Sooke each have existing wastewater treatment plants.
- On August 25, 2010, the Environment Minister approved Améndment No. 8 to the CRD LWMP. MOE is responsible to oversee and authorize the CRD's LWMP amendment process, and the consultation that forms part of that process.
- Amendment No. 8 outlines the current project which includes one secondary
 wastewater treatment plant at McLoughlin Point, one bio-energy facility, new trunk
 mains to convey flows to and from the treatment facilities, a storage facility in East
 Saanich to attenuate peak flows, and the necessary upgrades to the existing marine
 outfall and several trunk mains and pump stations to facilitate the project. The
 project is illustrated in the schematic attached as Appendix 1.

Title: Capital Regional District Core Area Sewage Treatment Project - Update

Issue: The Capital Regional District (CRD) has requested provincial funding for their sewage treatment project. CRD Board members, the Mayor of Esquimalt, and the Mayor of Colwood have each requested a meeting with the Minister to share their thoughts on the project.

This note is intended to provide information for all of these meetings.

Background:

- The CRD has committed to provide sewage treatment for the core area by 2016, and the Minister of Environment (MOE) has authorized the Liquid Waste Management Plan (LWMP) through which that commitment will be implemented.
- Through a series of LWMP amendments, the CRD is continuing to refine the details
 of the implementation plan. Part of the plan is the project that will provide the
 system and facilities for sewage treatment. The remainder of the plan details how
 the CRD will meet the other requirements of MOE such as monitoring and reporting
 of the effluent discharge and the receiving environment.
- MOE is responsible to oversee and authorize the CRD's LWMP amendment process, and the consultation that forms part of that process.
- The CRD recently submitted LWMP Amendment No. 8 to the Minister of Environment, and staff are reviewing it now. This amendment updates Amendment No. 7, which was approved by MOE last year, but the outcome of the plan – wastewater treatment by 2016 – does not change.
- The CRD had previously sought an inner-city site to allow the liquid and solids treatment facilities to be co-located; however they have been unsuccessful due to difficulties associated with constructing large conveyance pipes through existing streets and with land costs in developed areas.

LWMP Amendment No. 8

- LWMP Amendment No. 8 proposes to construct a wastewater treatment system to treat the sewage generated in the seven core area communities of the CRD including Victoria, Esquimalt, Colwood, Langford, Saanich, View Royal and Oak Bay.
- The proposed project includes one secondary wastewater treatment plant, one bio-energy facility, new trunk mains to convey flows to and from the treatment facilities, a storage facility to attenuate peak flows, and the necessary upgrades to several existing trunk mains and pump stations to facilitate the project.
- The project meets the provincial requirement for the best, lowest cost option for wastewater treatment as it provides the required treatment outcomes in combination with achievable greenhouse gas reductions and several resource recovery elements, all within a cost-effective scheme.

- The current siting plan places the wastewater treatment plant in Esquimalt, at what
 is now an old Imperial Oil (Esso) tank farm, the bioenergy facility at Hartland Landfill,
 and the storage facility in Saanich East, near the university.
 - Trunk mains will need to be constructed under the roadways of Fairfield, a tunnel will carry the sewer pipes across the harbour, and upgrades to existing pipes and pump stations will occur in several locations.
 - A pipeline will be constructed to carry pumped sludge from the treatment plant at McLoughlin Point to the bioenergy plant at Hartland Landfill.
- Resources to be recovered include: pipeline grade biogas to replace natural gas fuel, treated biosolids for use as a fuel substitute, and phosphorous (struvite) for use in fertilizer. The system also provides for a future heat recovery system for district heating in the James Bay area or in the DND development.

First Nations Considerations:

Detailed project background is included in Appendix 1 which provides the previous.

Discussion:

- Currently, the Province of British Columbia (Province) is discussing funding support for the overall project that will provide sewage treatment for the region.
- The level of support being discussed would provide for flexibility to allow the CRD and local communities to refine the project details and the procurement process that will be used.
- The provincial capital standard policy must be followed because the project involves more than \$50 million in provincial funds.
 - The standard requires Public/Private Partnership (PPP) procurement unless an alternate option achieves better value for taxpayers.
 - The configuration of the PPP will be identified through discussions between the CRD and Partnerships BC.
- A sound governance model is important to separate political process from technical project management decisions. An impartial and fair decision-making body should be comprised of individuals with the expertise and ability to see a project of this complexity to completion.

PROJECT DESCRIPTION

The project is intended to provided, at a minimum, secondary treatment to the core area of the CRD.

As part of its funding conditions, the Province will require the CRD to maximize recovery of resources (water, energy, nutrients) from the waste streams, while minimizing costs and greenhouse gas emissions.

The most current design configuration consists of:

- One secondary treatment plant at McLaughlin Point at the mouth of Victoria's Inner Harbour in Esquimalt.
 - Sewage that currently flows out the Clover Point Outfall will be pumped via a new force main along Dallas Road and under the entrance to the Inner Harbour to McLaughlin Point (Imperial Oil tank farm) for treatment.
 - Sewage that currently flows out the Macaulay Point Outfall will be pumped via a new force main under residential streets to McLaughlin Point for treatment.
 - All treated effluent will be pumped for discharge to the ocean via the Macaulay Point Outfall a new outfall will be constructed alongside the existing one.
- One holding tanking for wet weather flows in the Saanich East area (near UVIC).
- Various upgrades to the existing collection system and pump stations.
- Residual bio-solids, in the form of sludge, from McLaughlin Point will be pumped via a new high pressure force main to Hartland Landfill for disposal and/or beneficial resource recovery (e.g. methane production and/or composting).
- Various heat recovery technologies may be installed at key locations.

COMMITMENT TO SUPPORT THE PROJECT

In October 2006 at the UBCM convention, the Premier made a commitment to work with the Capital Regional District (CRD) and the federal government to identify the best, lowest-cost solution to provide for sewage treatment in Greater Victoria, and to contribute one-third of the funding to make that happen subject to consideration of a public-private partnership (PPP). This commitment was reiterated in the 2007 Throne Speech and again in a letter dated August 29, 2009, from Minister Bennett to the CRD.
