I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

A copy of The Aquatic Effects Study conducted by Golder Associates for the Transportation Ministry Project involving the Sweltzer Creek Bridge.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The Aquatic Effects Assessment is based on a project scope that includes bridge deck resurfacing works and in stream pile repair work. The project at Sweltzer Creek will be completed in two phases: deck resurfacing and associated abutment and road works are in progress and will be concluded in May. There will be no in stream work associated with this phase. The in stream pile repair will take place in the least risk fisheries timing window prescribed by Fisheries and Oceans Canada.

Your file is now closed.
