History of “Getting to Yes”

The 2014 *Range Act* amendments supported government’s objective for legislation to “get to yes” by:

- Removing government approval for a tenure holder to sell their excess hay,
- Enabling tenure holders to more easily manage their business model by subdividing or consolidating their tenures without government oversight,
- Making a more timely and transparent process for issuing new tenures on vacant crown land,
- Removing repetitive appeals on a disposition of a tenure while still respecting administrative fairness, and
- Adding new reasons to directly award grazing tenures to take advantage of short term grazing opportunities.
