*Previously issued access permit for 5349 Spalding Road, Vernon BC, Legal Description: PID 004-130-961, Lot 2, Plan 29894. The sketch submitted with the application, and map attached to the permit showing the driveway was approved to come off the public road and not pass through the neighbouring property; Any and all general documentation relating to the access of [specified location]. Timeframe is January 1, 1980 to December 31, 1983.*

The permit does not include, permit or approve locations beyond the immediate connection to the roadway. It is up to the applicant to ensure they locate any improvements with the right of way or their own property.
