**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

*A copy of any and all waivers the participants in the RBC Gran Fondo bike race event from Vancouver were required to sign; Any and all documentation to show when the stretch of road at or near the 85 km mark of the race was inspected for potholes from September 3, 2011 to September 10, 2011; Any and all documentation to show when a hole in the road relating to the MVA at or near the 85 km mark of the race was repaired.*

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

In addition, the Ministry has advised that it has neither records regarding a road inspection of potholes in the 85 km race zone, conducted within 7 days prior to the event, nor, records regarding repairs of the pothole.

Your file is now closed.
