I am writing further to your request received by the Ministry of Health on March 8, 2012. Your request is for:

- *“A table or list identifying which information technology services are provided to the ministry by ministry staff or through a contract, as of March 1, 2012. For services provided by ministry staff, the list of positions that perform each service, including title and classification.”*

Please find enclosed a copy of the records located in response to your request. These records have been provided to you in their entirety. Please note some information in the records is marked ‘not responsive’ as it does not respond to the wording and/or the date range of your request. Your file is now closed.

Additionally, the ministry has informed us that external contractor VFA Canada Ltd. provides information technology services to the Financial and Corporate Services Division of the ministry for the facility condition index database administration. The WebCAPS (capital project database system) of this division is managed by a ministry administrator and a supervisor.

These records will be published on the BC Government’s Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
