Any and all records including, but not limited to briefing materials, notes, emails, correspondence, memos, research documents, budgeting documents, cost analysis documents, cost breakdowns, cost of contractual agreements, employment hours and wages, used to determine and create the District of Sooke Official Community Plan that was adopted on May 17, 2010 particularly those documents that pertain to the rezoning of any District lands with an emphasis on Technical Industrial rezoning. Time frame is January 1, 2006 to March 8, 2013.
