**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Health. Your request as per your February 22, 2013, clarifications is for:

- **A breakdown of the various funding available for mental health services/programs in B.C. under the fiscal budget 2012-2013.**

Please find enclosed a copy of the records located in response to your request. The ministry does not generally allocate funds specifically to B.C. mental health services. It allocates funding to health authorities to deliver various programs and services. Health authorities are responsible for allocating the funding they receive to specific programs across the continuum of care, including mental health, in accordance with the health needs of their population.

For your convenience, the ministry has included in the records a list of web links to the 2012/13 service plans available on health authorities' websites. The service plans contain budgets relating to the Mental Health and Substance Use sector.

Please note that some information in the records is marked 'not responsive' as it does not respond to the wording and/or the date range of your request. Your file is now closed.
