On December 7, 2012, the Federal Government announced that it was granting Investment Canada Act approval for China National Offshore Oil Company's (CNOOC) acquisition of Nexen Inc. and PETRONAS' acquisition of Progress Energy. All records (including reports and correspondence) on the contracts or terms of approving these deals, the wisdom and advisability of these approvals, and all the possible and likely outcomes and consequences of these approvals.
