I am writing further to your request received by the Ministry of Energy and Mines, and Responsible for Housing. Your request is for:

The Evaluation Report done by the Ministry of Energy and Mines on Boss Power Corporation's Blizzard uranium mining claim, excluding any personal information and any records that have already been released publicly. Timeframe is April 1, 2008 to October 31, 2011.

The Ministry advises that the Spence report prepared on its behalf is publicly available, and Boss Power has also agreed to the routine release of the report prepared on their behalf.
