I am writing further to your request received by the Ministry of Environment. Your request is for:

Records related to pollution and waste produced by cruise ships that travel across Pacific salt waters over which Canada has jurisdiction, including but not limited to reports, studies, audits and evaluations, briefing notes, meeting minutes, public complaints from residents of British Columbia and United States government authorities, intergovernmental correspondence, correspondence with Port Metro Vancouver and Greater Victoria Harbour Authority and records that document the impact of cruise ship pollution and waste on the marine ecosystem around Vancouver Island and the lower mainland.

The date range is August 1, 2013 to [February 3, 2014].
