**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

*All documentation respecting an MVA that took place on November 3, 2011 at or near Highway 97 in Chetwynd, BC; All documentation generated by the ministry, the RCMP, highway maintenance contractors or employees and any other individual or entity respecting the ramifications of and follow up of the accident; All contracts with respect to highway maintenance for the area of the MVA and all correspondence with respect to highway maintenance within one mile radius of the accident from a point in time 48 hours prior to and after the accident.*

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 22 (Disclosure harmful to personal privacy) of FOIPPA.
