Mike,

I've done a review of our backlog and where it appears to be headed. Sorry for the length of the email.

### **Current Intake Levels**

According to the stats provided by Janette, there are currently **3,485 unprocessed files**. Of these, 182 have been assigned to advisors. The remaining 3,303 are still in queue awaiting assignment.

However, the provided stats only go up to September 2<sup>nd</sup>, which means that 2.5 weeks of inventory is not entered in the system yet. I went to the admin section and did a rough count of the September files that have not yet been entered in the system, and there are approximately 415 applications to be added to the queue.

This brings our total of unassigned files to **3,718**. If we include the files that are sitting on advisors desks with no decision, that file total increases to **3,900**.

### **Capacity and Processing Times**

Currently, we have 20 advisors. If all advisors, including the recently hired advisors, are performing at full capacity, we would process a total of up to **440 applications per month**. Thus, at full capacity, it would take us **just under 9 months** to get through our current inventory.

### **Intake Trend**

Our intake levels do not appear to be slowing down. The last time we received less than 440 files (our processing capacity) was in September 2013. Since then, we have been adding to our processing time because we cannot keep up with the intake levels. The last four months (May – Aug) we have received nearly double our output capacity – in that period our average intake was 763 applications/month. This is what has led to the significant increase in our processing times.

If this trend continues, and we continue to receive approximately 700 applications per month, we will receive another 2,800 applications before the end of the year. That would bring our backlog level to 4,940 (this is assuming we are able to process 440 applications/month for the four remaining months of the year).

### Filing Cabinets

Lastly, we are running out of physical space for the files. We currently have cabinet space to store about 3,200 files in our queue. Each drawer in a filing cabinet can store approximately 90 applications. Thus, we currently are short 6 drawers for our existing queue (I'm working with Mike Kim on that). My concern, though, is that by the end of the year, we will be closer to 19 drawers of cabinet space short for our queue. Even with the tall 4-drawer cabinets, we would need another 5 cabinets to store our queue.

Alberta has received a response from CIC to an enquiry regarding *Document Checklist IMM 5556*, which is used in support of *Application to Change Conditions, Extend my Stay or Remain in Canada as a Worker IMM 5710*.

We had noted that the checklist requirements do not differentiate between "regular" work permits and Open Bridging Work Permits, in that it suggests a letter of support from the nominating province is required from all work permit applicants.

CIC has advised that they will be working on clarifying the requirement for the statement/letter of support for nominees in the information/document checklists for work permits and work permit extensions.

We have asked CIC to add CPC Vegreville to the agenda for the teleconference September 24<sup>th</sup>. Please be prepared to discuss any issues your jurisdiction may be experiencing.
