*Copy of current contract between Windy Park Operations (Jerry McArthur) and BC Parks for providing Back country Park Operations in Strathcona Provincial Park, specifically looking for deficiency payment amounts made to Windy Park Operations from BC Parks for term of contract; Copy of previous winning proposal for this contract submitted to BC Parks by Windy Park Operations for Back country Operations in Strathcona Provincial Park; Records of Park User Fees (revenue) collected yearly by Windy Park Operations during this contract; Contract between Osprey Silviculture and BC Parks and deficiency payment amounts made to Osprey Silviculture from BC Parks for term of contract, for providing Back country Park Operations in Strathcona Provincial Park. Timeframe is April 1, 2005 to February 1, 2013.*
