I am writing further to your request received by the Ministry of Justice. Your request is for:

A copy of the Comprehensive Fire/Cause Determination Report completed by the Northern Regional Office of the Fire Commission and any other documentation available with respect to the fire that occurred at Happy Valley Elementary School, 3291 Happy Valley Road, Victoria, BC on October 14, 2004.

On February 17, 2015, we released to you records for a fire located at 3291 Happy Valley Road, however, they were not responsive to your request as they did not pertain to the school fire.
