# APPENDIX 1 Temporary Foreign Workers

## **BACKGROUND:**

- The TFW Program is a federal program jointly administered by Citizenship and Immigration Canada (CIC) and Employment and Social Development Canada (ESDC) formerly Human Resources and Development Canada (HRSDC).
- On July 15, 2013, Minister Jason Kenney was appointed Minister of ESDC and Minister Chris Alexander was appointed Minister of CIC. Prior to this date, Minister Kenney held the CIC portfolio from October 2008 until July 14, 2013.
- Under Minister Kenney, ESDC is responsible for Labour Market Opinions (LMO) which is designed to ensure Canadian workers are given priority over TFWs.
   Unless exempted from the LMO process (e.g. youth mobility programs, NAFTA), TFW's work permit applications must have an LMO. Through the LMO process, employers must demonstrate they have tried to recruit Canadians for their vacancies (e.g. through advertising positions on job boards).
- Under Minister Alexander, CIC is responsible for issuing work permits to TFWs.
   Work permits issued under the LMO process are usually valid only for a specific employer, job and length of time.
- In 2012, there were an estimated 74,216 TFWs in BC. Ontario had the largest share
  of TFWs in Canada (35.5%), with BC second (21.9%) and Alberta third (20.2%). A
  large proportion of TFWs in British Columbia (40 per cent) are admitted under youth
  mobility programs, which allow foreign nationals to work for any employer while they
  experience Canada.

- BC is using every available source of workers to address the workforce challenge of "jobs without people", while also investing heavily in upskilling workers to address "people without jobs".
- The BC's Skills and Training Plan specifies the importance of matching local workers first for jobs, followed by regional, national and finally international workers.
   The TFW Program plays a specific role among these priorities.

- In 2013, the TFW Program received heightened public and media attention mainly based on two controversies:
  - In BC, judicial review of ESDC's decision to issue a positive LMO approving the hiring of 201 Chinese TFWs by HD Mining.
  - In Ontario, the Royal Bank of Canada's decision to lay off 45 information technology workers and outsource jobs to a firm in India.
- In response to widespread concerns with the TFW program the federal government accelerated its program review, first unveiled in Budget 2012. In 2013, two sets of changes were announced, the first in April and the second at the end of July. \$13, \$16
- The province supports the TFW Program review and understands the federal government's requirements to ensure program integrity. In sectors where there are projected skill shortages such as liquefied natural gas however, the province must also support the use of TFWs by employers who are compliant with federal and provincial laws and who have genuinely sought to hire domestic workers but were unsuccessful.

#### **KEY MESSAGES:**

- Given his strong record of leadership on immigration reform, BC is pleased to be working with Minister Kenney on the appropriate use of temporary foreign workers. The work in this portfolio can build on positive realignment of Canada's approach to immigration for greater labour market responsiveness.
- BC supports the federal government's review of the TFW Program. Ensuring
  the program is only used when domestic labour sources have been
  exhausted and that appropriate mechanisms are in place to protect TFWs is
  of mutual interest.

- As the federal government continues its review of the TFW Program, BC is interested in learning what other program changes are under consideration and potential dates when these might take effect.
- BC is seeking a balance between improvements to program integrity and the need for expeditious access to TFWs for compliant employers that have legitimate workforce shortages.

SUBJECT AREA: Federal Review of the Temporary Foreign Worker Program

## **SPEAKING POINTS:**

- British Columbia supports the federal review of the Temporary Foreign Worker Program.
- As the Temporary Foreign Worker Program allows employers to fill critical vacancies across regions and industries, any changes stemming from the review must not result in additional barriers for bona fide employers to access foreign workers within reasonable timeframes.

**SUBJECT AREA:** Labout Market Agreement Renewal

## **SPEAKING POINTS:**

- We received the offer to renegotiate the Labour Market Agreement last Friday.
- BC has two key interests in a renewed LMA. The province must retain a strategic role in determining LMA investments and have sufficient flexibility to ensure economic and workforce goals are met.
- I know the federal government wants a Canada Job Grant, and BC is aligned with the idea of greater employer involvement; in fact BC delivers really successful LMA programs which require employer participation. We have a huge number of job openings coming on board, particularly in the North of our province with LNG projects, and we will continue to use this approach to meet labour demand needs.
