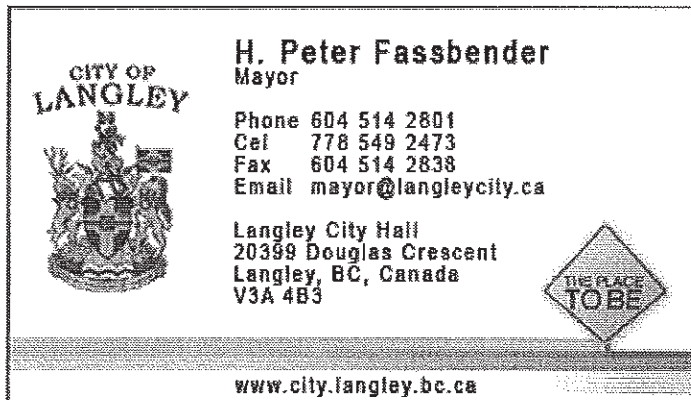
Clayton,
