All documents and correspondence related to PID 015-239-179 and PID 015-239-217 including historical background of lands from when they were removed from Semiahmoo First Nation Indian reserve lands; Any documents and correspondence in respect to the above properties or Semiahmoo First Nation and Vancouver, Victoria and Eastern Railway and Navigation Company, Great Northern Railway Company or Burlington Northern Santa Fe Rail (BNSF Railway). Timeframe is January 1, 1870 to February 21, 2013.
