


- 1. Dock exactly as shown on original application, extends 60 meters from HWL
- 2. Ramp as shown is 50 feet long, this is removed for the winter because of potential storm damage
- 3. Float(s) are also removed for the winter, we change size and configuration from time to time but they never extend beyond the lot lines and are near to the size shown.
- 4. Beaching ramp is slightly different from original but exactly as shown on drawing it is 6.5 meters wide and 40 meters in length.

All of these facilities are used by the camp in their activities for the campers and in accessing all supplies and materials. This is an isolated island as defined by ICBC (no car ferry) so this access is critical to our existence.

Thank you for providing this office – Fisheries and Oceans Canada ("DFO") with a copy of your January 4, 2005 letter to s.22 'Barnabas Family Ministries.

Your letter indicates that s.22 / Barnabas Family Ministries has sent an application to DFO for approval to construct a barge landing ramp on Keats Island.

DFO has no record of any submission from either s.22 or Barnabas Family Ministries either seeking DFO approval or providing notification regarding the construction of a barge ramp on Keats Island (or anywhere else).

We expect that Navigable Waters Protection Division ("NWPD") mis-read our December 22, 2004 letter to s.22 (we copied our letter to NWPD).

Our December 22, 2004 letter was our response to a December 10, 2004 e-note from s.22 to DFO. In her e-note s.22 described the construction of an existing barge ramp at the Barnabas Family Ministries camp on Keats Island, and asked for some specific clarification with respect to DFO interests.

It is our understanding that s.22 made her inquiry as a private citizen and member of the Keats Island community, and not in any association with the Barnabas Family Ministries or the camp on Keats Island.




