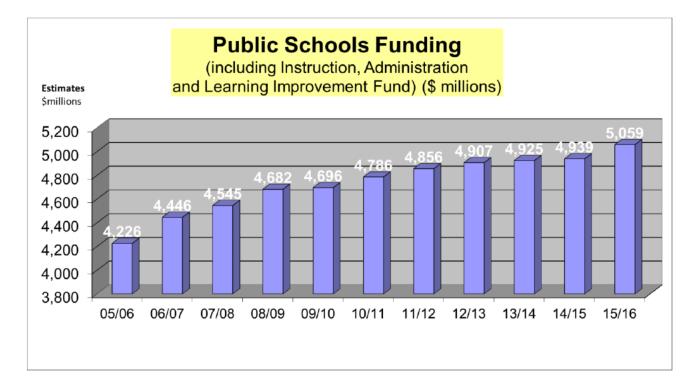


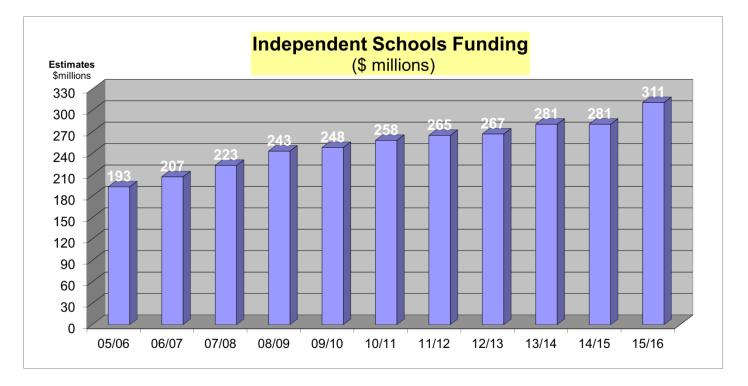
The Public Schools Funding Sub-Votes

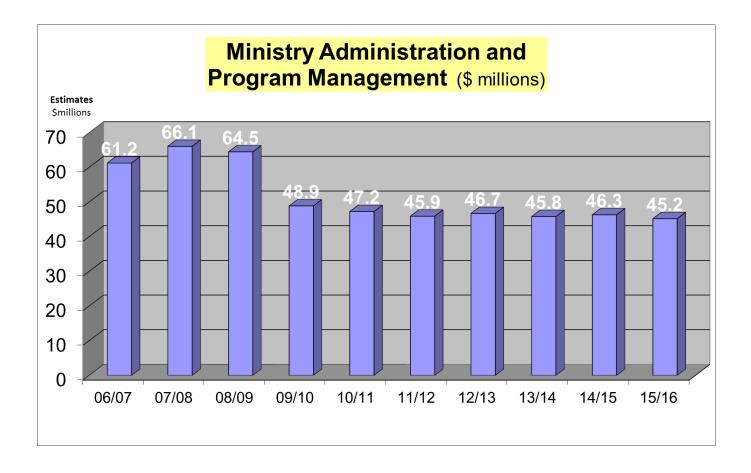
The Instruction and Administration sub-votes are made up of a portion of the operating grants to public schools (the Block) and several special purpose grants.

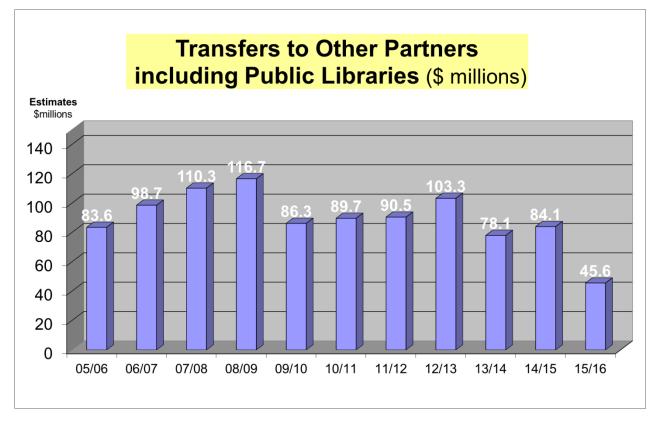

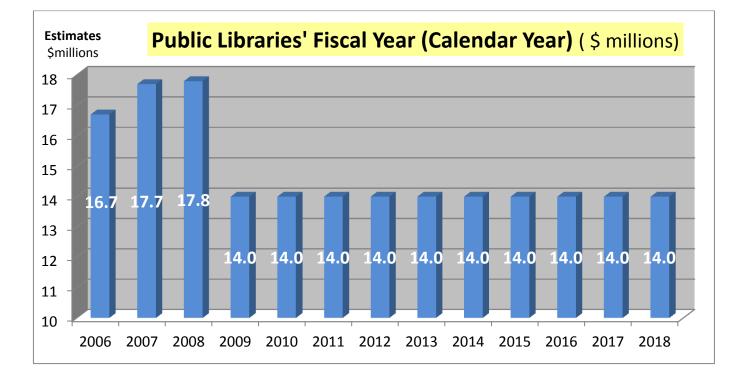








- The decrease in funding after 2008/09 resulted from the comprehensive government-wide review of all grants.
