OLIVER – Following a rigorous selection process, Plenary Justice has been selected as the preferred proponent to work with the B.C. government and finalize an agreement to deliver a state-of-the-art Okanagan Correctional Centre (OCC) – one of the final steps prior to putting shovels in the ground.
