As I mentioned earlier, section 7 came about as a result of a consolidation of a number of regulations that were in existence under the *Health Act*, consequent to repeal of most of the *Health Act* and it's replacement by the *Public Health Act*.

The wording of the new section 7 is virtually identical to what has existed since 1988 as the Health Hazard Regulation. Attached for background is also the repealed Health Hazard Regulation.

In addition I can confirm that to my knowledge there were no meetings of the Minister or any ministry staff with outside parties regarding this regulation, because there was no substantive change being made.
