SUMMARY:

Legislation

Section 17 of the ALC Act gives the ALC the authority to initiate and decide inclusions to the ALR if the commission "considers that the designation carries out the intent of the Act". A public hearing is required, and must be held in a manner consistent with the Regulations (notice period, structure of meeting etc).

Section 29 of the ALC Act gives the ALC the authority to initiate and decide exclusions from the ALR. A public hearing is required, and must be held in a manner consistent with the Regulations (notice period, structure of meeting etc).

Section 58 (3) (i) of the Act gives LGIC authority to make regulations "respecting the setting of boundaries of agricultural land reserves and the form, content, maintenance and correction of records of those boundaries". No such regulation exists.

Key message: ALC is not required to seek authority from Minister or Cabinet to conduct or conclude a boundary review, to notify

Minister/Cabinet of their intent to conduct such a review, or to inform Minister/cabinet of the results of a review.

SUMMARY:

Legislation

Section 17 of the ALC Act gives the ALC the authority to initiate and decide inclusions to the ALR if the commission "considers that the designation carries out the intent of the Act". A public hearing is required, and must be held in a manner consistent with the Regulations (notice period, structure of meeting etc).

Section 29 of the ALC Act gives the ALC the authority to initiate and decide exclusions from the ALR. A public hearing is required, and must be held in a manner consistent with the Regulations (notice period, structure of meeting etc).

Section 58 (3) (i) of the Act gives LGIC authority to make regulations "respecting the setting of boundaries of agricultural land reserves and the form, content, maintenance and correction of records of those boundaries". No such regulation exists.

Key message: ALC is not required to seek authority from Minister or Cabinet to conduct or conclude a boundary review, to notify Minister/Cabinet of their intent to conduct such a review, or to inform Minister/cabinet of the results of a review.

Dear Minister Pimm

I am writing this out of great concern for agriculture and our ranching members following this morning's report in the Globe and Mail regarding the reported proposal you plan to put before Cabinet.

The report seems to be in contradiction to some of what I understood you to tell me when we discussed this on the phone on October 1st.

You indicated that there could be some division of how things are sectorized in that some regions may be handled differently and this seems to be the case with separating out the Okanagan, Fraser Valley, and Vancouver Island. We see where this can make sense and be more efficient.

Our concern really lies with the other region north of the Okanagan. I asked specifically if this was being driven by the desire of government to address the development of LNG and the oil and gas sectors and you assured me that this was not the case and that they were satisfied with their allotments. According to the information we are receiving right now it would appear that you would be turning a major portion of the decisions over land development over to the BC Oil and Gas Commission.

I feel that if this is the case you will find that the vast majority of the cattlemen and members of the BC Cattlemens membership would be vehemently opposed to this and that it would largely be regarded as the "fox guarding the Henhouse" and that while we agree that there needs to be an ability for development to take place to allow for economic growth, it CAN NOT come without consultation, input, and future involvement in the decision making process by the Ag sector.

I am sending you this by email as we feel this is a very urgent concern. We are receiving many media calls about this announcement today. I am trying to address them by giving government the benefit of the doubt in believing that they feel that agriculture truly is important in BC. We have worked hard to live under the guidelines of the ALC for the last 40 years. We hope that this administration takes that into account and is not throwing those of us who have built the industry and the province for the benefit (or betterment?) of all under the bus.
