Re: Temporary Licence Suspension (De-Licensing) - December 2, 2012 and January 12,

2013 event

Establishment: The Rickshaw Liquor Primary Licence # 304738

The Liquor Control & Licensing Branch received your application for temporary change to the above-noted licence on November 6, 2012 for all ages events on December 2, 2012 and January 12, 2013.

I understand that you have had discussions with Donna Lister regarding both events and that you agreed to withdraw your application for December 2, 2012. Your co-operation in this regard is appreciated by all. My staff has sent a letter to rescind the approval to you under separate cover so that your normal licence will be in effect on that date.

With respect to the all-ages event on January 12, 2013, I have received representations from both the Regional Manager and the Vancouver Police Department. Both agencies have raised serious concerns about this event and oppose it going forward as an all-ages event.

Their concerns stem from the significant increase in assaults and robberies in the immediate vicinity of the Rickshaw, with young people forming a large part of the victim group. Police advise me that the Rickshaw finds itself at the hub of a neighbourhood plagued by violent crime. The recent gang slayings raise additional concerns about the potential for retaliation in and around licensed establishments.

I share the Regional Manager's and Police Department's view that it is not appropriate to bring young people into the area. I understand that although there is a transit bus stop and bench in front of your establishment, the bench is regularly used by various establishment patrons and persons who frequent the area. Across the street are store front alcoves that are used after stores close for the night as temporary shelters for persons living on the street. Minors using the Skytrain would need to walk a significant distance to get public transit which increases the risk of harm.

In view of the significant potential safety concern for minors, I am denying the application for January 12, 2013.

Hi Tom,

Yes, the intent of the policy directive is that licensees would be limited to 4 – 6 temporary changes (defined as events) per year regardless of the type of change. Licensees are encouraged to apply for permanent changes if they want to have hours extended frequently. There may be some exceptions for area extensions where it is not possible for licensees to apply permanently (for example, an outside space) and we would consider those on a case-by-case basis. Wherever possible, we want licensees to be looking for permanent changes if that's how they want to operate.

The de-licensing for alternate use for all ages events will not be permitted for the reasons we have set out.

Hi Cheryl,

Can you clarify whether the limit on the number of temporary changes such as hours extensions and area extensions is included within the limit of 4-6 per year? (for example, an LP would be limited to 3 hours extensions, 2 area extensions and 1 de-licensing in a year)

That's how I read the following statement on page 3: Since alternate use during licensed hours requires a temporary change application, and in keeping with the new policy limiting the number of temporary change applications, the total number of temporary change applications, including temporary de-licensing for alternate use, are subject to the above policy restricting them to in the range of 4-6 per year.

However, earlier in the document, it notes: In keeping with the original intent of the licence category and considering branch resources, temporary de-licensing for licensed establishments is now restricted to in the range of 4-6 events per year.

Subject: LCLB Policy Directive 12-09: Alternate use

Policy Directive 12-09, regarding alternate use, has just been posted to the Liquor Control and Licensing Branch's website.

The purpose of this policy directive is to announce amendments to policy:

- Limiting the frequency of events for which temporary changes to a licence may be issued;
- Clarifying the types of events for which a temporary suspension to an LP or LP club license may be issued to permit alternate use of the establishment during licensed hours, and
- decreasing the amount of time required as a separation between licensed hours and an SOL event or unlicensed alternate use.

These policies come into effect on January 15, 2013, and apply to all events scheduled on or after that date.

Hi Donna and Alex,

Thank you for passing along this request. As Donna has so astutely pointed out in her email, the Rickshaw finds itself at the hub of a neighbourhood plagued by violent crime. There has been a significant increase in assaults and robberies in this neighbourhood, with young people forming a large part of the victim group. The latest trend is iPhone robberies – thieves are targeting people talking or texting, using distraction and taking their phones. Some thieves have resorted to violence thus making it a robbery.

In addition to the increase in violent crime, we are seeing a high level of liquor-related offenses in this area, offences related to people suffering from mental health issues or addiction issues and quite often, these incidents turn violent. This is not a place to inject a large number of young people, day or night.

I don't anticipate the view of the VPD will change on this issue, until crime rates and incidents of street disorder drop significantly.

Inspector Davey, the Branch has received an application from the Rickshaw (200E Hastings) to de-license for 2 all age events. The dates for these events are December 2<sup>nd</sup> and January 13<sup>th</sup>.

This application is to temporarily suspend the liquor license to hold an event to which minors can attend.

Although similar, it is not the same as Vinyl as it is not confined to a particular school, the minors will be coming from everywhere in the lower mainland.

I believe that the concerns, however, are the same in that we would experience an influx of minors into the heart of an area riddled with a significant increase in violence, drugs, liquor and mental health issues.

In order for me as the Regional Manager to deny this application I need to have VPD support and input. I am wondering if you could send me an email briefly outlining why you do not support this application.

The Liquor Control & Licensing Branch (Branch) received your application for a temporary change to the above-noted licence on October 19, 2012 for two all-ages events for November 8 and 21. 2012.

As stated in the letter dated October 16, 2012 (letter attached), there has been an increasing rise in crime and liquor-related incidents in this area; as such, the Branch questions the suitability of the environment for a group of minors to gather. These concerns were brought forward by Donna Lister, the Vancouver Regional Manager of Compliance and Enforcement Division (Regional Manager), and the Vancouver Police Department (VPD).

I understand that there was a discussion between the applicant, and Alex Clarke, VPD, regarding these upcoming events; however the VPD has since confirmed with the Branch that they do not support these two upcoming events for reasons stated above.

The principle concern regarding the proposed event is not derived as a result of the manner in which the establishment is operated; rather, it is a result of the concerns with the area in which the establishment is located. The Branch acknowledges that the licensee agreed to implement security measures to monitor the minors within the establishment during the event, including arranging drop-off/pick-up services; unfortunately, even with these measures in place, the licensee cannot maintain control over the activities of neighbourhood.

In view of the fact that the Regional Manager and Vancouver Police Department do not support the change requested, the application is denied.

I just spoke with Alex Clarke who is the liquor coordinator for the Vancouver Police department. She just finished a meeting with Inspector Michelle Davey who is the District 2 area commander.

You should have on record her email regarding the Modern and Fabric requests for all age events, in particular her non-support.

The same reasons for non support apply to the Vinyl application, but with additional stronger reasons. The Vinyl is located in the same hotel as the Pint which has become a very popular place for a young demographic to frequent and drink. The Vinyl entrance is on Abbott Street very close to an alley frequented by unsavory characters. This street also gets very busy with people who are in line to get into Pint, and those who have been drinking and come outside to smoke. The vacant lot across the street is a frequent problem for police.

This hotel is also a stones throw (1-1/2 blocks) from the heart of skid row. Violent crime (robberies; assaults) has gone way up in this area recently.

This temp change is not supported by the VPD or myself.

- this new "entertainment district" is not built with the wide sidewalks which allows better (and safer) movement of people, including those who are intoxicated in the neighbourhood. It is also very close to the DTES where we have had a significant rise in violent crime over the past few months.
- this establishment is in close proximity to other licensed establishments where we have a constant challenge in managing liquor related incidents and street disorder. As you point out, there were 30 incidents in a single night requiring police attendance. This in my view is not a safe environment to inject a mass of young, underage people.
- anecdotal information from beat officers working in the area is that Thursdays are quite busy some of the bars have lineups, which take up much of the sidewalks in Gastown, they are dealing with fights and disorderly conduct and in their view, it would not be a suitable environment to inject a large number of young people.

Thursdays are typically the start of the weekend bar scene for many people. If you were asking me about a Sunday night then there may be a different answer to this question.

I am not supportive of either event.

Please let me know if you would like to discuss it further.

The Liquor Control & Licensing Branch received your application for a temporary change to the above-noted licence on April 19, 2012 for a May 12, 2012 event and just recently for another event for May 18, 2012.

It has come to my attention that in a previous recent all ages show that took place April 20, 2012, there were incidents involving five minors that resulted in involvement with the West Vancouver Police and Emergency Medical Services. This is a serious matter.

I have been advised that security measures were implemented to manage and monitor the minors within the establishment during the shows; however, there were questions and concerns with the measures used to initially identify any students under the influence prior to their entrance into the establishment. The licensee is responsible for ensuring that security measures are adequate to prevent such incidents from occurring in the first place.

I understand there was a discussion between the licensee and Liquor Inspector, Heather Lahoda, that the school involving these five students would be banned from participating in any other all ages shows. I am not satisfied that this measure is sufficient to address the serious public safety concerns.

As stated in our previous approval letters regarding temporary changes for all ages show, "if any event previously approved has not been managed to the satisfaction of the General Manager, all remaining dates will be cancelled. Future approvals for similar temporary changes will be conditional on this event(s) being managed to the satisfaction of the General Manager."

Given the serious public safety concerns associated with the previous event, I am not prepared to approve further requests suspending the licence for all ages shows. The application for May 12<sup>th</sup> and 18<sup>th</sup> has been denied.

The Ocean Club Tapas Bar (Lounge) Licence # 159281 has had four 'all ages' events in the last two months. It is my understanding that they will be applying for two more in May. Although two of the four past events went off without a hitch, the first one was a bit of a gong show in that the students advertised the event on social media (facebook/twitter) which led to a number of kids being turned away at the door once capacity had been reached. The event was never over crowded. The police attended to manage crowd control of those turned away that were spilling into the parking lot. There were no other incidents. I discussed the concern with the manager and he assured me that he had spoken to the other schools planning to hold events there and that he didn't anticipate anything future crowd control concerns. (I have checked with West Vancouver Police and they advised me there were no more crowd control or overcrowding issues.)

The forth event held April 20, was for West Vancouver High School. There are two different stories being told regarding this event. One is that the licensee discovered 3 intoxicated females on site and removed them immediately calling their parents to come collect them. The females admitted to the licensee that they snuck mini bottles of alcohol into the premise in their bras. The Police maintain that upon a walk through they discovered 5 intoxicated minors, 3 females and two males. One female was so intoxicated that EHS was called. She was cleared and released to her parents on the scene. The police attended at 22:18. It is my concern that these students were already intoxicated, or well on their way, when they arrived at the club and should've been detected by the security team upon arrival and not permitted entry.

The licensee (third party operator) has two more all ages events ready to go for May. One on May 12 for Windsor High School and one on May 18 for West Vancouver high School. I advised him that I would not support the May 18<sup>th</sup> event for West Van High. He has contacted West Van High and advised him that he is cancelling their event due to the conduct of the above. He had a waiting list of schools and approached Centennial who asked for an event on May 19<sup>th</sup>.

I have concerns for future all ages events with this operator. Page two of letter sent approving the first 4 events stated that "if any event approved in this letter is not being managed to the satisfaction of the General Manager, all remaining dates be cancelled. Future approval for similar temporary changes will be conditional on the event(s) being managed to the satisfaction of the General Manger." Although the students attending the first 3 events were not an issue and the licensee has taken steps to prevent the students of the 4<sup>th</sup> event to hold another fundraiser at the club, I'm torn in providing support for the last two events in May. I find it hard to believe that 5 people could get intoxicated on the amount of minis that the 3 females would've been able to smuggle into the establishment in their bras. Police also reported to me that the third party operator was argumentative and refused to provide them with his personal details when asked.

This establishment has been sold and the keys are being handed to the new operator May 22.

I am fine with whatever decision makes for the pending events.

Sirs and Mesdames,

I am writing you all this email as I would appreciate a meeting with the City and the RCMP to discuss the letter that was recently sent to the City Council from Corporal Deb Postnikoff. I would prefer to meet face to face to discuss this issue. However, I will provide some commentary below.

Firstly, I would like to say that from day one, my family and I have always been open communicators and have always willingly participated in roundtable discussions on the social (plus other) impact of our business on this community. We are invested in this community not only financially, but otherwise and have an interest on our reputation and on the well-being of our patrons.

With all due respect to Corporal Postnikoff, I find it upsetting that her scathing letter does not represent all the facts surrounding our events. I am not going to point out the misinformation within her letter here. I would however like to comment on the theme of her letter and my opinions. We can leave the rest for our Page 28 meeting. EGM-2013-00015

We operate our business in the City of Castlegar. We pay over every year. We s.22 unlike many nightclub owners in other communities and larger centres are hand-on, caring and community minded citizens. We are very respectful of the liquor and other laws, the RCMP, and other agencies. We care about our business, continue to invest in it and continue to give back to the community in any way we can.

We have gained approval to do these Teen events through the LCLB in part because of our track record in running previous events (3-5 per year since 2006). We follow all the rules and regulations (in addition to our own extra safety policies) and have adequate staff and we do a very good job of monitoring the event. The notion that an adult/parental supervised event would result in perfectly behaved teens is fantasy. One look no further than high school dances that resulted in the same behaviour amongst the few. (we do let parents in to come and have a look and see what happens inside)

During the last event, the RCMP was called by us as we believed that that was the responsible thing to do. It seems as though, by calling the RCMP to deal with those few, we have brought on the wrath of the RCMP themselves. The events surrounding our last dance are not typical of our events and for the most part with the exception of a few minor problems, the events operate smoothly and are enjoyed by all.

The concern of the RCMP should be any illegal activity. While I respect Corporal Postinkoff's right to opinion, I find it very disappointing that her personal opinions of this event have blurred the lines on her duty as RCMP. It is not the duty of the RCMP to impose their moral and ethical beliefs on my business, nor on individual parental decision making. Youth drink. It's a fact. We are not an enabler of this, nor does our establishment promote youth drinking, mini skirts or drug abuse. It is very concerning to me that youth get involved in that type of behaviour. However, let's not blame the bushes on the bush parties and let's not blame the Element for the social problems of today's youth. Our establishment provides less alcoholic imagery than Boston Pizza and the beer commercials on TV and the internet. Our venue promotes miniskirt usage on a far lower magnitude than the pages of Teen magazine and Glee on TV.

We are constantly thanked by parents for offering the opportunity for their children to participate in these types of events. Parents have the right to not allow their children to partake. We provide a great venue and event for these youth and we will continue to provide these services as long as there is demand.

Please contact me to discuss a meeting time and I will be there. Our next event is February 19th.

RE: Element Teen Dances in Castlegar

We are writing to you to express concern regarding the Element Teen Dances taking place in Castlegar. The last dance that occurred in December left many issues that spilled over into the school in the time that followed. The buzz in the school consisted of rumors of arrests, students going to the "drunk tank", students going under the influence of alcohol or sneaking alcohol into the venue, drug use, fights, etc. While we understand that this is not a school event, it has significant ramifications on the school for an extended period. Our counsellor's spent significant time working with students to resolve issues arising from their attendance at the dance.

Our main concern is the safety of our students. Other concerns include the impact these dances have on our attendance rate the following day and the social issues that spill over into the school and the emotional dysfunction we observe in some of our students that have a direct impact on their academic achievement. Several staff has expressed their concern to us regarding the dances and the impact it has on students and their classrooms.

Our Vice Principal, Ms. Lavender, made a call to RCMP the day following the last dance regarding the activities of SHSS and Crowe students at the dance held at the Element night club to express her concern. Our other Vice Principal, Mr. McKenzie, spent over an hour on the phone with Marty Kooiman, Drug Awareness officer for the RCMP, discussing the ramifications to Stanley Humphries as well.

The school's mandate is education. In dealing with the issues that today's youth face we have worked in conjunction with Interior Health, Freedom Quest, the Public Health nurse, Castlegar and District Community Services, Get Comfortable, Men Speaking Out, Trail Mental Health and Substance Use Services, WINS Transition House Outreach, the Saleema Noon Group, the SD20 Health and Lifestyle committee, and the local RCMP in delivering relevant, up to date information and on good decision making.

We are concerned that our students are identifying one of their social outlets as a night club prior to them being 19 years old. As a community stakeholder it seems like we are at a cross purpose in supporting students to be healthy contributing citizens.

There is another Element Teen dance on February 19<sup>th</sup>. We are concerned again, about the impact this will have on the health and welfare of our students.

It is my understanding that the concerned participants involved in developing this response suggest that these conditions would apply to the Feb 19 event only and will reassess after the event. It seems reasonable that they could be included as a requirement for the Licensee.

### Regarding the remaining dates:

I'm not sure we should provide a specific RCMP commitment as a T&C. We are making the RCMP response a responsibility of the Licensee. I'm not certain that the RCMP will be able to commit the resources for this event on an ongoing basis. I am awaiting a reply from the RCMP regarding this. I do not expect a response before Wed evening.

In the absence of the RCMP response and written conditions from the LG, I recommend the following additional T&C's for the remaining dates:

- 1) The Licensee will cooperate fully with RCMP and provide full support in whatever capacity required.
- 2) In addition to servers, at least 10 staff will be present to supervise the event and monitor the washrooms.
- 3) Community stakeholders (such as local government representatives, Interior Health, Public Health Nurse, Castlegar and District Community Services, Freedom Quest, Trail Mental Health and Substance Abuse, WINS Transition House Outreach, etc) as well as all parents will be warmly welcomed and encouraged to attend the club during the night.
- 4) The Licensee will refuse entry to anyone showing any signs of intoxication. Specifically the Licensee must employ suitable measures to identity any children showing signs of alcohol or drug use and refuse them entry.
- 5) The Licensee is strongly encouraged to ensure that safe measures of addressing intoxicated children is available. Such measures would include medical care and/or transportation.

I received a complaint about the Element regarding minors, entertainment and the youth dances. I have forwarded you the complaint for your information. The complainant is anonymous so I am unable to follow up with an interview.

I telephoned Florio regarding this complaint and he described his version of the incident on Dec 11, 2011. He said there were no assaults. There was no crack. Staff discovered youths with street drugs in washroom. Florio claims that this is the first time he was aware of drugs at an Element youth event and he phoned the RCMP.

Florio further explained that he has met with you (Laurel) and discussed this incident.

## Additionally:

- 1. The LCLB is currently reviewing the policy on delicensing liquor primaries for youth events and may discontinue approval for all future applications.

### Teen Dances at the Element Nite Club

Dear Mayor Chernoff and City Councilors,

I am writing this letter to express my concerns from not only a policing stand point, but as a concerned parent, relating to the Teen Dances at the Element Nite Club. I am hopeful, as are many of the other police officers in the Castlegar Detachment, that the teen dances will cease immediately. Many concerned citizens and parents mirror my concerns and are appreciative that this matter is finally getting addressed. The most recent teen dance was held on December 11th, 2012, which has sparked and raised various concerns within our Detachment and in our community that I feel need to be acknowledged and addressed.

One must ask, if it is recognized by British Columbia Lottery Corporation that exposing kids merely visually to gambling (casinos, gaming centers, and even scratch tickets) drastically increases their chance of gambling addictions and related problems, why on earth would a teen dance be permitted in a bar? I don't necessarily think the concept of a teen dance should be squashed, but I think a change of venue would be more appropriate.

To gain a better understanding on how such an event gets its approval, I contacted the local Liquor Inspector, Jim BOOTH who stated that the teen dances have to be approved by the General Manager of the Liquor Control and Licensing Corporation. A temporary change application is made to the existing licence that holds the sale of all liquor for the requested time period. The liquor is then expected to be secured. This allows for families and of course minors to be inside the establishment (bar) during this temporary period where alcohol is not being served. Jim BOOTH also stated that support from the local government and police are to be obtained to hold such teen dances. The Castlegar RCMP has never provided support, nor been made aware that such teen dances were even going to take place in our community.

The Element has done this on two occasions that I am aware of. They will host a "Family Dining" hours, then host a "Teen Dance" following dining hours. Having dinner with the family is obviously acceptable. Placing teens ages 13-18 years of age into a poorly supervised, non-chaperoned bar environment is another issue. Why are parents never canvassed and provided the option of attending and chaperoning the event? Can two or three bar bouncers supervise hundreds of teens? The combination of alcohol, drugs, hormones and adrenaline clearly was not effectively managed by Staff at the Element during the last teen dance.

Jim BOOTH advised that the General Manager is currently actively assessing these teen dances within British Columbia, specifically, in Vancouver and Victoria, which have been victim of these teen dances resulting in problems of vandalism to property and teenage drinking.

In speaking with police officers that were on duty during the last teen dance, one member quotes:

..... "the attitude of the persons attending the dance is that it is like a rave and a chance to get blasted. The youth just deal right in front of staff and do lines in the bathrooms. This is usually what we look for in adults using cocaine and other drugs, not from 15-17 year old youths,"

This officer also stated feeling "sick" after working this shift and having arrested 15 year old kids for being drunk in public and for possession of drugs. It felt as though all recent efforts on getting the drugs off the streets were made readily available in one establishment, in just a couple hours. This police officer found this depressing.

Further, this police officer stated that in the past three years of his tenure in Castlegar, there has been only two other events that rivaled the amount of drugs seized from an event. These were Shambala and the mini-Shambala that was held at the Element. The drugs that were being seized off of these youth were not marihuana joints, common to many youth. The drugs were MDMA (Ecstasy) and Ketamine (known to youth as "Special K")

Ketamine is primarily used in veterinary medicine and essentially the same as PCP. Individuals anesthetized with Ketamine feel detached or disconnected from their pain and environment. A person who is on Ketamine has superhuman strength and all forms of pain compliance do nothing as the person cannot feel anything. For a such a small price, the effects of this drug can be very severe and in some cases, deadly.

MDMA (Ecstasy) is marketed as a "feel good" drug and is a psychedelic-amphetamine. It is both a hallucinogen and a stimulant like methamphetamine. The addiction potential is high. MDMA is a very dangerous and unforgiving drug that also can have severe side effects and cause death, especially when combined with other drugs or alcohol.

Another police officer (and parent) who was also on duty at the last teen dance states:

...."As a constable with the RCMP in Castlegar and a parent, I am against the Element holding these teen dances. In my profession, I deal with a lot of people, (not all) that are affected by the atmosphere of the Element. These are supposed to be mature adults, but seem to not be able to use the simple life lessons they are taught as children. We then send several hundred teenagers into the same atmosphere and the problem seems to multiply."

..... The amount of drugs seized from the Element at the last teen dance was astonishing. The feeling by many people afterwards was, 'well only a few bad apples will ruin it for everyone'. It is these few bad apples that could potentially send me to some ones house and explain that a 'bad apple' had made a bad decision and now their child is in the hospital and might not make it, or even worse has passed away. Due to the small town atmosphere of Castlegar, I would potentially know these kids and parents. That would be not only devastating to the family but to the community as a whole.

s.22 I am also, after talking to parents that do drop their children off, astonished that it is believed that there is adult supervision at these events. It is my understanding that there are a few 'bouncers' tending to the door, doing a coat check and walking around the floor, but I am sure the ratio for kids to 'adults' is pretty low, and not able to handle the issues presented."

From my understanding, teen dances carry certain rules for those attending. Teens are not to attend the dance after consuming alcohol, bring in alcohol inside the bar, or 'go in and outside' the bar after paying the cover charge. It is rumored that the youth are sharing alcohol and other substances while waiting in the line-up prior to their entry into the bar. This goes on for up to an hour. Who is monitoring the line-up? Obviously, youth have been concealing various types of drugs on their person and bringing them inside the bar, as several youth were found in possession of drugs and/or using them inside the washroom. Staff also identified tables to Police where suspected drug activity was taking place. Police officers working that evening have stated that although there were only five youth arrested for either selling or using drugs, there were a LOT of youth observed to be "high" and displaying symptoms of having consumed drugs. If parents knew just how free flowing the Ecstasy and Ketamine were at this event, they may feel differently about allowing their children to be there for future events. These teen dances at the Element are facilitating a place for young drug dealers to distribute their "garbage product" to other youth.

As we are aware from media headlines, the potential problems, especially with Ecstasy and this PMMA (form of Ecstasy), have contributed to deaths and overdoses (8 in Alberta recently and Nelson last week). In my opinion, this simply outweighs the benefits of having such an event.

From a policing perspective, these events are a huge drain on resources. Specifically, the Castlegar Detachment was not made aware that such an event was taking place until the evening of the event. Should there have been a serious altercation inside the bar, how could police have been prepared to respond with minimal resources on shift? It is imperative the police be made aware in advance of such events. What about a safety plan in the event of a fire? Did any of the Staff have proper First Aid certification? Have the Staff been security cleared to work with children?

Teen dances have obviously been around for a long time. The idea means well, however, the unchaperoned venue, is not acceptable. It was also observed that many of the youth attending these teen dances at the Element are dressing provocatively in outfits that are not suited to their current age group. Mingling 13 year old girls with 17 and 18 year old boys in such an environment is concerning. Although there have been no reported incidents of sexual interference, there is huge potential when you mix alcohol, drugs and hormones. The lack of supervision only adds fuel to the fire. Further, these teen dances at the Element are not just limited to Stanley Humphrey. Secondary Students, but open to all neighboring cities. There is the potential for rival -type assaults occurring when you are mixing and mingling youth from outside of the city of Castlegar. At least when teen dances are held at the school, you are only dealing with the students that actually attend that school. The Principal of Stanley Humphries Secondary School always advises the Castlegar RCMP when they are hosting a school dance and request patrols to enhance the supervision already in place by Staff and parent volunteers. They are typically uneventful and well controlled.

In conclusion, the Element hosting teen dances is not supported at many levels. I do believe, with the right venue and supervision, having our children attend a teen dance/party is a wonderful idea. Putting them in an environment that was built for mature adults (Exotic Dancers/ Foam Parties/ Fetish nights/ Cage Rage, to name a few events) with inadequate supervision is not a suitable venue. I am hopeful that the City of Castlegar will review and re-visit future teen dances at the Element. It has been confirmed that the next teen dance is scheduled on Sunday, February 19th, 2012 from 800 PM-1100 PM.

Perhaps this is a topic we need to involve our community members (parents, teens, grand parents, Police, Government officials, concerned citizens, Media, stake holders etc) to discuss and make decisions on the continuance or cancellation of these teen dances at the Element?

If a teen overdoses or dies at one of these teen dances at the Element, many of us will be asked why we didn't step up and try and stop these dances from continuing after making observations on the numbers of "high kids" inside the bar coupled with the availability of drugs observed at this event on Sunday, December 11th, 2011. How will we respond to the parents of that child or answer to the Community as a whole?

The last dance that occurred in December left many issues that spilled over into the school in the time that followed. The buzz in the school consisted of rumors of arrests, students going to the "drunk tank", students going under the influence of alcohol or sneaking alcohol into the venue, drug use, fights, etc. While we understand that this is not a school event, it has significant ramifications on the school for an extended period. Our counsellor's spent significant time working with students to resolve issues arising from their attendance at the dance.

Our main concern is the safety of our students. Other concerns include the impact these dances have on our attendance rate the following day and the social issues that spill over into the school and the emotional dystruction we observe in some of our students that have a direct impact on their academic achievement. Several staff has expressed their concern to us regarding the dances and the impact it has on students and their classrooms.

Our Vice Principal, Ms. Lavender, made a call to RCMP the day following the last dance regarding the activities of SHSS and Crowe students at the dance held at the Element night club to express her concern. Our other Vice Principal, Mr. McKenzie, spent over an hour on the phone with Marty Kooiman, Drug Awareness officer for the RCMP, discussing the ramifications to Stanley Humphries as well.

I think it is pretty clear from our conversation that we won't agree on the topic of Teen Dances. While I respect that the RCMP should have input on this matter, it is disappointing nonetheless that the RCMP can't support this event due to some disturbances in the surrounding area. While my event clearly gets teens excited and provides them a venue to have a good time, we are certainly not enabling teen drinking, sexual activity or police beatings. I believe that we agree on this point, however, it is frustrating that my business is clearly being pointed at. There will always be problems when any number of people congregate in one area and this fact should not restrict the potential for me to host these events.

I have had on average 3 events a year for the past 5 years; that is 15 nights out of 1800+ days. In that same amount of time, there have been 500+ weekend days of bush parties, house parties and such that include teen drinking, driving and other activities that compromise safety and well-being. I find it very difficult to believe that my few monitored and regulated events create so many problems from a policing standpoint that its just easier to shut them down, put people out of work and make it that much harder for a local tax paying business to function is this small community. If it were like that everywhere, we would not have professional sport venues or stadium concerts due to the massive congregation of intoxicated and rowdy fans. The Shambalah music festival is policed (even by Castlegar RCMP) and supported even though there is a massive drug and alcohol problem there. Not only is there a large percentage of teens at this event, but they are mixing with adults. Again, I find it very frustrating that we can't as a group find a way to make this work.

As discussed at the meeting yesterday, the event and the crowd was managed very effectively in the immediate vicinity of the Element. The people in the line-ups were well behaved, people inside were well behaved and while three teens were sent home (by way of parents) for being intoxicated, I thought that from our point of view that the event was run very smoothly. In our meeting Jim Booth re-iterated my observations however neither of us were aware of what happened blocks away in the Park behind the library or at Millennium (which may be unrelated). In addition to this, school principles and their concerns about a shutting down a business should have no bearing on my event. Teens not showing up for school is a parenting issue, not an Element issue.

There is no question that

that had that not happened, we wouldn't have had the discussion we did yesterday. To be completely
frank, it seems that again, that the RCMP is passing judgement on the morality/ethics of my event when the real
discussion should be on how to police it. I also suspect from our conversation that if the RCMP had more
resources to provide policing that we would then be able to put on an event that quells some of your concerns.
My establishment pays a

a year and the expectation as a business is that the services
are there to support us. We have continued to pay our taxes and support the community and charities through
good times and bad. Over the last 4 year period we went from being open 3-4 days a week in the nightclub
accommodating upwards of 1300+ people per week to currently being open 2 days a week and averaging a total
of 250 people which has resulted in a significant drop in RCMP calls to the Element. It seems that 3 Sundays a
year is not too much to ask for.

While the LCLB may be revoking future events due to your non-support, they may actually be changing policy all together which makes my rant moot anyway. I certainly

I know that this is just business and it is not personal and appreciate the general support of the RCMP over the years. I have always valued working closely with the RCMP and Jim to make sure my establishment has as little negative impact on the community. If it were like that everywhere, we would not have professional sport venues or stadium concerts due to the massive congregation of intoxicated and rowdy fans. The Shambalah music festival is policed (even by Castlegar RCMP) and supported even though there is a massive drug and alcohol problem there. Not only is there a large percentage of teens at this event, but they are mixing with adults. Again, I find it very frustrating that we can't as a group find a way to make this work.

As discussed at the meeting yesterday, the event and the crowd was managed very effectively in the immediate vicinity of the Element. The people in the line-ups were well behaved, people inside were well behaved and while three teens were sent home (by way of parents) for being intoxicated, I thought that from our point of view that the event was run very smoothly. In our meeting Jim Booth re-iterated my observations however neither of us were aware of what happened blocks away in the Park behind the library or at Millennium (which may be unrelated). In addition to this, school principles and their concerns about a shutting down a business should have no bearing on my event. Teens not showing up for school is a parenting issue, not an Element issue.

There is no question

s.22 that had that not happened, we wouldn't have had the discussion we did yesterday. To be completely frank, it seems that again, that the RCMP is passing judgement on the morality/ethics of my event when the real discussion should be on how to police it. I also suspect from our conversation that if the RCMP had more resources to provide policing that we would then be able to put on an event that quells some of your concerns. My establishment pays a s.21 and the expectation as a business is that the services are there to support us. We have continued to pay our taxes and support the community and charities through good times and bad. Over the last 4 year period we went from being open 3-4 days a week in the nightclub accommodating upwards of 1300+ people per week to currently being open 2 days a week and averaging a total of 250 people which has resulted in a significant drop in RCMP calls to the Element. It seems that 3 Sundays a year is not too much to ask for.

While the LCLB may be revoking future events due to your non-support, they may actually be changing policy all together which makes my rant moot anyway. I certainly

s.22 I know that this is just business and it is not personal and appreciate the general support of the RCMP over the years. I have always valued working closely with the RCMP and Jim to make sure my establishment has as little negative impact on the community. From the day we opened our establishment we have been community minded and will continue to be even though this decision will make it harder for us to do business in these very tough economic times.

Dear Mr. Nathan Robinson.

I thank you for forwarding us your letter addressed to Jim Booth and the LCLB.

I hope you and the rest of your staff appreciate that we care about this community and the effect our business has on it. We have worked hard at being good corporate citizens and giving back to the community in many different ways. We are involved in various community organizations and strive to make Castlegar a better place for our families. This makes it all the more disappointing to see a letter that directly attacks what we do.

While we understand the concerns of your letter, we are frustrated that our business and this event is continually being pointed at as the cause for the problems you list. I have been very open and have worked closely with the RCMP, LCLB and the City of Castlegar at making these events as safe as possible. In fact, at our October 28th event, Jim Booth, many parents and the Citizens on Patrol were inside our event keeping a watchful eye. At previous events, City Councillors, Laurel Mathews of the RCMP and concerned parents were also present. For you to judge our event based on rumour is unfair. In the future it might be a good idea to find out first hand from people who were at the event or to come and see what happens yourself. Jim Booth, at a recent meeting told RCMP that the line-up and crowd was very well-behaved and other than a few people that were caught with alcohol outside, the people inside were behaved and having a great time. These echo my observations of responsibility amongst most of the worth.

It's easy to point fingers at us because we are a big shiny building downtown, but we are not the originator of the problems you mention. The schoolyard fight existed long before the Element had it's first youth event and I suspect that it will continue in our event's absence. There were a few problems in the blocks around the Element that night that were unfortunate, specifically the altercation between a student and an RCMP officer. While I am upset that something like that happened near my establishment, I take offence at the insinuation that we are somehow at fault. We are the cause of "at risk behaviour" as much as the trees are at the weekend bush party. While there is no doubt that there is some social spill-over at the school on the day following our event, this is absolutely no different than the social fallout of a weekend house party or even your very own school sponsored dances. All social outlets play a part in the lives of teenagers and the challenges you face.

We recognize that anytime you have an event with 400+ people, old or young, there are bound to be some problems. We have had on average 3 events a year for the past 5 years; that is 15 nights out of 1800+ days. In that same amount of time, there have been 500+ weekend days of bush parties, house parties and such that include teen drinking, driving and other activities that compromise safety and well-being. I find it very difficult to believe that educated people such as yourselves truly believe that shutting down our very few monitored and regulated events will put an end to at risk behaviour among teens, and solve the social and academic problems at the school. It is unfortunate that your energies are so focused on our business and events. It is equally disheartening and nonsensical that you believe that our events create so many issues from a school standpoint that it's easier to just try and have the events shut down as if they are the root cause of the school problems.

We are not doing anything illegal or contravening any laws, yet rather than having the courtesy of discussing this issue with me directly, you choose to write to the LCLB and the local liquor inspector, RCMP and others. "Community Stakeholders" such as yourselves are supposed to be proactive and work together with all parties to find solutions, which I have always been open to and as I suggested in a letter to SHSS numerous years ago. Remember, we are community stakeholders as well and we have a vested interest as this will ensure our business is able to continue to prosper, employ local people, pay taxes and contribute to local charities and the local economy.

It seems very clear to me that we will not agree on this matter. However, if you are interested in having a constructive and open discussion, I would be more than happy to meet so that we may be part of a solution. Please feel free to contact me at florio@clubelement.ca or at 250-365-8066.

Cheryl,

I attended a meeting with the RCMP and LG on Monday to discuss concerns about teen dances at the Element. There are concerns about drug and liquor use with the children as well the suitability to use a liquor primary for events for children. There was a significant show of support from the city council to allow the Element to continue to have the teen dances. The general consensus was that the Element was not responsible for all of the problems but that everyone could do more to help protect the children.

From my perspective this issue is bigger than the Element. I have worked with 3 venues in Nelson who have attempted to regularly host youth events. Two Licensed establishments structured their hours of sale and utilized the "Alternate use outside licensed hours" policy for teen events. One business discussed options for liquor licensing in detail with me and then chose to open an unlicensed club to provide a opportunity for teen dances separate from the family and adult events. All three of these businesses were overwhelmed by problems associated with alcohol and drug abuse as well as community complaints of vandalism, assaults and late night noise. None of them continued with the teen events.

There are additional delicensed nights at the Element scheduled for:

February 19, 2012 March 11, 2012 April 22, 2012 May 6, 2012 June 3, 2012

I am forwarding the letters received from the RCMP and School District in Castlegar.





RE: Element Element Teen Complaint - InformDances in Castleg...

I have also received an anonymous complaint that alleges over 100 members in the community do not support teen dances at this establishment. The complaint quotes comments from the community including:

- 1. It's like they (the Element) are grooming my teenager for drinking/doing drugs and trying to get into the Element under age.
- 2. Why on earth have such things when the kids go there knowing that they aren't properly supervised and they perceive the evening as anything goes.
- 3. Some wonder if the drugs/booze themselves come from inside the Element.
- 4. Have you seen the drinking that happens as they want in line?
- 5. Under age kids just shouldn't be in such an establishment because at the end of the day it's a night club and it only makes the kids think its ok to drink and/or do drugs.

- 6. One of the biggest question is why does the RCMP and the City of Castlegar let these dances continue
- 7. Many didn't realize that entrance is not only limited to those High School students in Castlegar. Some parents were concerned about the non-reportable fights between Trail and Castlegar boys that are not called into the RCMP.

I received a complaint about the Element regarding minors, entertainment and the youth dances. I have forwarded you the complaint for your information. The complainant is anonymous so I am unable to follow up with an interview.

I telephoned Florio regarding this complaint and he described his version of the incident on Dec 11, 2011. He said there were no assaults. There was no crack. Staff discovered youths with street drugs in washroom. Florio claims that this is the first time he was aware of drugs at an Element youth event and he phoned the RCMP.

Florio further explained that he has met with you (Laurel) and discussed this incident.

#### Additionally:

- 1) The LCLB is currently reviewing the policy on delicensing liquor primaries for youth events and may discontinue approval for all future applications.
- 2) Florio is aware we have had several complaints regarding minors at the Element and I have advised Florio (and Nick) that staff should check 2 pieces of ID THOROUGHLY, **EVERY TIME** a young looking person enters the premises.
- 3) Strippers and exotic dancers are not permitted to physically contact each other or patrons.

These are commitments made by the Security Mgr, Mr. Joe Ghattas, hired by Motel for this event. I am satisfied with the plan and after conferring with RM Donna Lister and VPD Liquor Coordinator Alex Clarke I am prepared to support the application.

In regards to Motel nightclub...

Motel is having an underage event in February. I have talked to Andre in length about the possible risks and the challenges of underage events could bring. On that note, Andre gave me an unlimited budget and full control to do what I need to get done to ensure a safe event. As you know I have done many underage events in my time. We have had nothing worse than having to call parents/VPD to pick up their son/daughter that started fights or snuck in alchohol.

I will have at Motel:

- •Staff roaming the parking lot to make sure no one tries to pre drink. The usual at these events is to drink a "big gulp" while in line, to go around the corner slamming of a Mickey so they appear sober upon entry and it hits them 10 minutes later inside.
- •Anyone deemed aggressive, intoxicated or under the influence will not be allowed in.

•All man bags, purses and jackets will be coat checked to minimize drug dealing.

- •Even though it is a minors event we will still be scanning ID if they have it and if not we will be still taking photos of all those that enter. This will allow if needed, to ID someone thru the treo scope picture via networking of kids attending. Primarily I have used this practice to give the minors the illusion that "police" can find you if needed and we are serious here.
- •Full pat downs and metal detection will be in effect. As standard practice for minors, we will employ a female to search the girls. Again, as usual in these events the girls put alcohol in zip lock bags to avoid being detected by metal detectors and place the bags in their bras. Also, alcohol is put in hairspray bottles, hand sanitizer bottles and all other bottles.
- •No people over the age of 19 will be allowed in.
- •Staff inside will do female/male bathroom checks every five minutes in case some alcohol did make it in.
- •We will not open the patio/smoke pit to ensure no ejection or turn always are tempted to jump the fence. They are minors and are not permitted to buy cigarettes, so we will not give them a place to smoke.
- •No in's and out will be permitted.
- •I have spoken with representatives of "safe ride" and have a hand full of safe ride cards to hand out incase teens are stranded.

We will be using the blocked off/fenced secure patio as a place" if needed to safely hold ejected minors till parents arrive. That way we do not let them roam the streets alone. If you have any questions or concerns, please let me know.
