- Pricing Formula: Provide the all inclusive hourly rate (excluding taxes) of the primary resource roles to be assigned to the project. The hourly rates listed may also be used for any authorized work that may occur outside of the initial contract.

The additional work (in this case the refinery analysis) is within the expertise of the contractor. Existing rates were used as per those included in Navigant’s response to the RFP.
